BACKGROUND

- An Urban Water Management Plan (UWMP) is mandated to be prepared by every urban water supplier, as defined in the California Water Code Section 10610 et seq;
- 2. And updated every five years for calendar years ending in "0" or "5".
- 3. Riverside Public Utilities update must be adopted and submitted to the California Department of Water Resources (DWR) prior to July 1, 2026.

BACKGROUND

This UWMP summarizes RPU's:

- 1. Projected retail and wholesale water demands.
- 2. Characterizes the source waters available to meet those demands for the next 25 years.
- 3. Describes the reliability of RPU's water supplies and,
- 4. Discusses RPU's water shortage contingency plan during a catastrophic event or drought conditions.
