FEE OPTIONS

- Flat Fee*
 - Time and materials approach
 - o Reduced administrative impacts
- Deposit Method:
 - Time/fees charged against deposit
 - o Requires tracking time, processing refunds
- Agreements, Tax or CUP:
 - Additional fee tool to address community issues
 - o Additional time, process and varying results

FLAT FEE

- Use Guidelines to identify tasks
- Calculate direct costs using hourly rates
- Determine other operational costs
- Determine indirect or "overhead" costs

PROPOSED FEES

Phase 1: Application Review: \$13,842

- Fee submitted with each application
- Application review, evaluation (ranking)
- Application Form, Business Proposal, Operations, Safety/Security Plan

Phase 2: Site Selection: \$17,864

- 14 highest ranked applicants
- Preferred location
- Zoning Verification
- Site Improvements/Certificate of Occupancy
- Local and State Licenses
- Operational Agreements

RECOMMENDATIONS

Staff recommends that the City Council:

- 1. Hold a public hearing to adopt an ordinance amending Chapter 3.30 Section 3.30.030IV of the Riverside Municipal Code to add an additional category to the Schedule of Regulations, Products and Services Titled IV. Community & Economic Development - Planning;
- 2. Adopt a Resolution amending the City's Fees and Charges Schedule providing for two Storefront Retail Commercial Cannabis Business Permit fees: (1) an Initial Application Fee and (2) a Site Review Fee; and
- 3. Provide direction to staff to return at a later date for Council to consider the amendments to the Ordinance to establish fees related to Annual Renewal. Appeal, Change of Business Location, and Transfer of Permit.
