A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 21052 TO AMEND PARTS III AND IV OF THE FRINGE BENEFITS AND SALARY PLAN (AND ADDENDUMS) TO REFLECT VARIOUS UPDATES AND CHANGES.

WHEREAS, Resolution No. 21052, the Master Fringe Benefits and Salary Resolution was adopted by the City Council on October 4, 2005, and includes the Fringe Benefits and Salary Plan for said employees; and

Section 3: Authorize the City Manager, or his designee, to make minor, non-substantive changes to Master Fringe Benefits and Salary Plan and any related policies, procedures or documents necessary to implement these provisions.
