

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, ADOPTING A REVISED ENFORCEMENT RESPONSE  
4 PLAN FOR THE CITY'S PRETREATMENT PROGRAM AND REPEALING  
RESOLUTION NO. 21255

5 WHEREAS, provisions of the Federal Clean Water Act of 1987 and the City's National  
6 Pollutant Discharge Elimination System Permit No. CA 0105350 require the City to have and  
7 administer a pretreatment program, one element of which is an Enforcement Response Plan; and

8 WHEREAS, the Enforcement Response Plan is a guidance document for the  
9 implementation of enforcement actions for violations of the City's pretreatment program; and  
10

11 WHEREAS, section 14.12.495 provides that the Enforcement Response Plan is to be  
12 adopted by resolution of the City Council; and

13 WHEREAS, on September 19, 2006, the City adopted Resolution No. 21255, adopting the  
14 City's current Enforcement Response Plan, which was later updated in 2009; and  
15

16 WHEREAS, the Enforcement Response Plan must be periodically reviewed and amended  
17 to incorporate changes in the pretreatment program's enforcement actions and procedures; and

18 WHEREAS, changes to the Enforcement Response Plan include designated employee  
19 changes, creation of a tiered enforcement penalty schedule, improved clarity of enforcement  
20 procedures, additional enforcement actions and an improved enforcement matrix summary; and  
21

22 WHEREAS, the changes to the Enforcement Response Plan have been approved by the  
23 California Regional Water Quality Control Board, Santa Ana Region; and

24 WHEREAS, staff now recommends that the City Council adopt the revised Enforcement  
25 Response Plan, and repeal Resolution No. 21255.

26 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
