AGREEMENT TO REINSTATE, AMEND, AND EXTEND THE AGREEMENT FOR PROFESSIONAL SERVICES (Adult/Adolescent Forensic Services)

WHEREAS, the City of Riverside ("CITY"), a municipal corporation of the State of California, on behalf of the Riverside Police Department ("RPD") and the County of Riverside ("COUNTY"), a political subdivision of the State of California, on behalf of the Riverside University Health System - Medical Center (RUHS-MC), sometimes collectively referred to herein as the "Parties" or individually referred to as a "Party", agree to reinstate the Agreement for Professional Services (Adult/Adolescent Forensic Services) originally executed between them on or about November 15, 2022 ("Original Agreement").

WHEREAS, the Original Agreement expired on June 30, 2023.

WHEREAS, the purpose of reinstating the Original Agreement is so that it may be amended and extended to allow the Parties to perform their respective obligations under the Original Agreement.

WHEREAS, COUNTY and CITY desire to amend the Original Agreement to extend the Term by exercising the renewal options set forth in the Original Agreement;

NOW THEREFORE, the Parties agree as follows:

- 1. To reinstate the Original Agreement and extend the expiration date of the Original Agreement to September 1, 2023, so that the Agreement shall be considered to have been in effect from the commencement date through September 1, 2023 under the same terms and conditions.
- 2. Period of Performance. Section 2.1 Period of Performance is hereby amended to read as follows;
 - "This Agreement shall be effective upon signature of this Agreement by both parties and continues in effect through June 30, 2024, unless terminated earlier. This agreement may be renewed by written amendment for up to one (1) additional year(s) through June 30, 2025.
- 3. Miscellaneous. All other terms and conditions of this Agreement are to remain unchanged.
- 4. Effective Date. This Agreement to Reinstate, Amend, and Extend the Original Agreement shall become effective upon signature of both Parties.
- 5. This Amendment may be executed in any number of counterparts, each of which will be an original, but all of which together will constitute one instrument. Each Party to this Amendment agrees to the use of electronic signatures, such as digital signatures that meet the requirements of the California Uniform Electronic Transactions Act (("CUETA") Cal. Civ. Code §§ 1633.1 to 1633.17), for executing this Amendment. The Parties further agree that the electronic signatures of the Parties included in this Amendment are intended to authenticate this writing and to have the same force and effect as manual signatures. Electronic signature means an electronic sound, symbol, or process attached to or logically associated with an electronic record and executed or adopted by a person with the intent to sign the electronic record pursuant to the CUETA as amended from time to time. The CUETA authorizes use of an electronic signature for transactions

and contracts among parties in California, including a government agency. Digital signature means an electronic identifier, created by computer, intended by the Party using it to have the same force and effect as the use of a manual signature, and shall be reasonably relied upon by the Parties. For purposes of this section, a digital signature is a type of "electronic signature" as defined in subdivision (i) of Section 1633.2 of the Civil Code.
