

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, RELATING TO CALPERS
4 RETIREMENT COST-SHARING UNDER GOVERNMENT CODE
5 SECTION 20516 BY UNREPRESENTED POLICE MANAGEMENT
6 EMPLOYEES IN THE POLICE SAFETY GROUP.

7 WHEREAS, Unrepresented Police Management employees of the Police Safety group of
8 the City of Riverside (“City”) are not covered by a memorandum of understanding; and

9 WHEREAS, changes to wages and benefits for Unrepresented Police Management
10 employees of the Police Safety group are recommended by the City Manager and approved by
11 the City Council; and

12 WHEREAS, the City is interested in having all CalPERS Classic, Tier 1 and Tier 2 (hired
13 before June 13, 2012), Unrepresented Police Management employees in the Policy Safety group
14 participate in employee cost sharing towards the CalPERS retirement benefits pursuant to
15 Government Code Section 20516; and

16 WHEREAS, CalPERS requires that the City Council adopt a resolution that specifically
17 identifies the following information for Unrepresented employees in order to initiate the process
18 for the City to amend its CalPERS contract to provide for Section 20516 (Cost Sharing) as
19 follows:

- 20 • Unrepresented Cost Share Percentages to become effective as soon as
21 administratively possible with CalPERS:
 - 22 a) 7.0% for Classic, Tier 1 and Tier 2 (hired before June 13, 2012),
23 Unrepresented Police Management employees of the Police Safety group
- 24 • Unrepresented Cost Share Percentages to become effective on as soon as
25 administratively possible after December 20, 2024 with CalPERS:
 - 26 a) 7.5% for Classic, Tier 1 and Tier 2 (hired before June 13, 2012),
27 Unrepresented Police Management employees of the Police Safety group

1 WHEREAS, a majority of the Unrepresented Police Management employees of the Police
2 Safety group impacted by this cost-sharing amendment have signed this resolution as shown on
3 Exhibit "A" attached hereto and incorporated by reference.

4 NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Riverside,
5 California, as follows:

6 Section 1: That the above recitals are found to be true and correct and are hereby
7 incorporated as if stated in full.

8 Section 2: That this resolution complies with CalPERS' procedures for Unrepresented
9 employees needed in order to initiate the employee CalPERS contract amendment process under
10 Government Code Section 20516.

11 Section 3: That the City Council approves this resolution to initiate the employee CalPERS
12 contract amendment under Government Code Section 20516 for Classic, Tier 1 and Tier 2 (hired
13 before June 13, 2012), Unrepresented Police Management employees of the Police Safety group.

14 Section 4: That this resolution shall become effective as soon as administratively possible.


