I am Rami Ray, former name: Farzana Khanam, a spiritual guru at Shri Vishnu Spiritual Ashram in Riverside; my only purpose is to dedicate my life to God and humanity. As a citizen of the United State of America, I have no criminal records, moving violations, or parking tickets; my record speaks for itself.

I am writing this complain about Councilmen, Chuck Conder. I first met the councilmen, at a Good Morning Riverside meeting at the Mission Inn, on August 8th; I was introduced by Patricia from the Chamber of commerce, because I had asked her, who was our councilman for Ward 4; we exchanged Business Cards and had a brief conversation. During our conversation, I informed him that our organization was planning on developing a big project in Riverside, and I would like to discuss this with him regarding the possibilities and opportunities. He seemed to be very enthusiastic and interested to meet and discuss our project; he asked me to call or email him for a meeting. The next day, August 9, I called and emailed him, but did not hear back from him, nor did I get a response to my email. Then, on August 13, I called and texted him, but did not get a reply from him or his secretary.

He has been ignoring my phone calls, text messages, and emails. I don't know him personally; nor do I have any personal interest in him. The only reason I wanted to contact him was for the project we would like to propose here in Riverside. We need to buy a minimum of 10 acres of land at a minimal cost, preferably, from a government source for our nonprofit organization project. Our plans are to build a Hindu temple, an Ashram, senior homes, guest housing, a swimming pool, a parking structure, and a small park.

Unfortunately, I never heard back from councilman Chuck Conder and I'm certain that he was negatively influenced by an individual that is trying to destroy my reputation and my future plans and goals for the community. Councilman Conder was influenced by Ali Sajjad Taj, a councilman from Artesia. Instead of meeting with me, finding out more about us, and doing some investigation regarding our organization and me, he has completely ignored us. As a councilman and a public servant, he has an obligation to his constituents and the businesses of his Ward. It doesn't appear he is fulfilling the job we elected him to do, and therefore, should be disciplined or even removed from his councilman position.

On September 12, I met the mayor Patricia Lock Dawson at Mission Inn, Good Morning Riverside. I requested an appointment with her and she advised I speak to her scheduler Kathy; I wanted to talk to the mayor about Councilman Chuck Conder. I emailed Kathy for an appointment and she said the mayor's schedule is full for next 6 to 8 weeks, so she is

unable to meet; if I would like, she could schedule me with the mayor's chief of staff, Ruby. I scheduled an appointment with Ruby and met with her at Riverside city Hall on September 19, at 9 AM with my Dad to complain about the councilman Chuck Conder.

I moved into this city and bought property and start a nonprofit organization here in Riverside, the city of opportunity and hope. I believe that this hope is alive here in Riverside and Ward 4, but I believe it would be in the best interest of all, that the city assign another councilman or city individual to work with us towards the fulfillment of our project, here in Riverside.

I met Ali Sajjad Taj, Pakistani, councilman of Artesia three years ago in 2021, through my assistant Raj Trivedi, architect, in the grocery store. I don't know him personally, but he has awarded me, Divine Soul Rami a certificate of recognition for my community service in 2021, and another to our ashram, Shri Vishnu Spiritual Ashram, in 2023. We never had any kind of personal relationship. As a public figure, spiritual guru, I often see him at public events in Indian community, where we are always cordial and say hi to each other. To help clarify why he changed from supporter to an antagonist; you should know that he has proposed to me on a couple of occasions, but I politely rejected his proposals because I am a spiritual guru, and I have dedicated my life to God and humanity. That is my spiritual calling, so this is my life. Furthermore, he called me a couple of times close to midnight to talk, but I did not answer the phone; I have phone records to prove it. Since these rejected proposals, he has been intentionally attempting to tarnish my reputation and damage my spiritual career by sending negative messages about me to 15 different city mayor's offices in Southern California.

Because of his negative publicity about me, my reputation has been seriously damaged. Furthermore, it has been tremendously affecting the income and the finances of our organization. The City of Irvine, the City of Lakewood, and the City of La Palma was ready to award a certificate to Shri Vishnu Spiritual Ashram in January - February of 2024, but for some reason changed their mind and stopped communicating with us all together. These three offices were influenced by Ali Sajjad Taj; these three mayors are friends of Ali Taj. I will get a Subpoena from the court to testify and the computer record will be checked. I will go to Washington DC, file a case and will have a Congressional inquiry about Councilman Ali Sajjad Taj; I want fairness and justice. We don't want to be a victim of a dirty politician.

I have been giving free service to the community, as well as, all over California for the past 9 years; people come to me from Sacramento to San Diego. There are people that have met me in zoom meeting or even come from out of state just to get my service and blessings. I don't deserve to be treated like this. Councilman Ali Sajjad Taj announced his candidacy for the State Assembly district 67. He should be punished and he doesn't deserve to be a member of the Congressional 67th district.

In my career, it is quite common to have individuals become antagonistic towards me. Part of my services is spiritual counseling. During this counseling, I often will read a person's energy to identify what is going on in their life. After I read the energy, I can guide them properly. Sometimes this identifies affairs or cheating of husbands or wives and boyfriends or girlfriends; sometimes family or friends are not acting in the best interest of the individual I'm counseling. Because my information uncovers infidelity and deceitful people, the result is individuals in the society that become a vindictive enemy, and retaliate by spreading negative rumors about me to destroy my reputation. I even had people threaten me over the phone with bodily harm, rape, and death. People like Ali Sajjad Taj, take advantage of this situation to take revenge.

As a spiritual guru, my serious concern is if the politicians start listening to rumors, disrespecting us, and treating the citizens poorly, then where do the ordinary people go and how do they get service, fairness, and justice? Can we trust them?
