

**FIRST AMENDMENT TO
MEMORANDUM OF UNDERSTANDING
FOR REIMBURSEMENT OF CROSSING GUARD SERVICES**

THIS FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING FOR REIMBURSEMENT OF CROSSING GUARD SERVICES (“First Amendment”) is made and entered into this _____ day of _____, 2024, by and between the CITY OF RIVERSIDE (“City”), a California charter city and municipal corporation, and the RIVERSIDE UNIFIED SCHOOL DISTRICT (“District”), herein “the Parties”, with respect to the following:

RECITALS

WHEREAS, on or about September 26, 2019, City and District entered into that certain Memorandum of Understanding for Reimbursement of Crossing Guard Services (“Memorandum of Understanding”); and

WHEREAS, the City and District desire to add six (6) additional crossing guard locations, with the District to reimburse One Hundred Percent (100%) of the costs for the additional locations to the City.

WHEREAS, the City and District desire to amend the Memorandum of Understanding to extend the term to June 30, 2025.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement:

1. Section 1, Term, is amended to extend the term to June 30, 2025.
2. Exhibit “A” is hereby amended and replaced in its entirety with Exhibit “A-1.”
3. All other terms and conditions of the Memorandum of Understanding between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
