My name is Bonnie Ayala Rodrigues; I was born in Casa Blanc and resided there for almost 20 years. I am writing to request for the band shell at Villegas Park to be considered for dedication in the memory and honor of my parents Valente "Glen" and Mary Ayala for their many years of selfless service to the community of Casa Blanca and the City of Riverside.


My father, Valente "Glen" Ayala served as the first director of Villegas Park for over 20 years. During his tenure as director, he made it a priority that *all* the children in the community have the opportunity to receive services regardless of race, color, or financial background. He refused to charge for programs that families could not afford to pay. He suffered emotional and personal financial loss for this by taking a pay cut in his salary, but he would not waiver from addressing the needs he saw before him. His sacrifice for the children was a lifetime of gain and memories for many. A price he paid with great humility. Upon his death, many current and former residents shared how my father changed and touched their lives. Stevie Smith, assistant coach for the LA Sparks basketball team said, "Your Dad saved my life. He was like a father to many of us. Most of us did not have fathers and he became one to us. He took us under his wing." Due to his love of the community, individuals began to feel welcomed enough to call him by various nicknames: *Chump, Champ, Old Man, Mi General and Grandpa*.

On several occasions, my father would allow residents to play at the park past his scheduled work hours and return later in the evening to turn off field lights. These acts of kindness kept many of the youth out of trouble. Education was also a top priority to him. Again, on many occasions he supported and contributed financially to those that were seeking a higher education. He once gave a young woman whose mother was from Mexico, money to buy a computer to do her college assignments. This individual had no father and the mother did not speak English. He cared so much that over time some of the kids in the community started to call him "Grandpa." They would ask him "Grandpa, can I have a dollar to buy an ice-cream?" "Grandpa, can I have some money to go swimming?" He was a man with an indescribable amount of love and kindness. It did not matter to him who you were what you looked like. His joy was seeing opportunity and advancement for the youth and the community. Often he would say, "If a man asks you to walk a mile, walk with him two, three, four miles. Keep walking until he does not need your help anymore. Don't deny your brother in need." He lived by the words that he preached. Such a man of wisdom and stature was he that the mayor and chief of police of Riverside befriended him. These relationships he used to benefit those in need.

Mary Ayala is remembered as a fierce community activist and a force with which to be reckoned. When she spoke, people listened. I remember how she would step in as a liaison for Spanish speaking parents and school administrators. Due to the closure of the Casa Blanca Elementary School, it became her goal to make sure that the children and their parents had all the information and services required. Her fight was for education and equality for the Hispanic people. It angered her that the community as she once stated, "Was being taken advantaged of and discriminated against." She gained no monetary benefits for taking a stand but pride in what the future would hold for the minority. Due to the poor treatment the Hispanic people were enduring, my mother would take a stand and make her concerns known. The activist she became many remember her to be. This also got her the attention of Cesar Chavez with whom she worked on several issues at the time. She was instrumental in fighting for programs that benefited the underprivileged in the education system as well as the city and became one of the first members for the board of Concelio Centro De Niños, a preschool that catered to low income Spanish-speaking families. Mary also served and worked on various projects: *Title 7, Casa Blanca Community Action Group, Brown Baggers, Community Service Organization, Redevelopment, the Bilingual Program, and the California Board of Equal Educational Opportunity Commission.* There are other areas of work too numerous to mention.

It is to my knowledge that today many are benefiting from the selfless mentoring and sacrifices donated by both of my parents, and will continue to benefit from in the future.

To the Riverside City Council,

My name is Steven M. Smith and I have been asked by the family of Glen Ayala to share with you my experiences with Glen and how he impacted my life. I am currently the Athletic Director at one of the most prestigious private schools in the country called Windward School of Los Angeles. I have served in this capacity since the year of 2000. Also, for the past 15 years, I have been an assistant basketball coach or scout in the WNBA (Womens National Basketball Association) for the following organizations: The Phoenix Mercury, Los Angeles Sparks, Detroit Shock and the WNBA organization its self. Prior to coaching in the WNBA, I was a head mens basketball coach at a small liberal arts college in San Rafael, California called Dominican College. My tenure their was from the years of 1990 to 1997. I also played basketball at Dominican College in 1987 and I played at Marin Community College from 1984-1985.

I was born and raised in Riverside, California in a community called Casa Blanca. Our neighborhood was filled with many kids who's fathers were not present in their lives and as a result, we kids faced many situations that could have lead us down the wrong side of the road. Unfortunately, many of my childhood friends that I grew up with chose to go down the wrong side of the road and are deceased or living a life of incarceration. Those of us who were able to move on with our lives to have careers and families owe a tremendous amount of credit to a man who helped father all of us, Mr. Glen Ayala. Glen was the director of our local park named Villegas Park. Glen ran adult basketball leagues, adult softball leagues, youth basketball leagues, youth flag football leagues,

youth softball leagues and made Villegas park the most popular gym in the entire city of Riverside. I can remember as a little boy waiting for the day that I could play basketball at Villegas park with the older guys on Saturdays and Sundays after church. Every weekend, kids from East Side, West Side (Rubidoux) and Hill Side came to Casa Blanca (Villegas Park) to play basketball. Eventhough Casa Blanca was known in the Riverside Press Enterprise as a community that was full of drugs, gangs and many other violent crimes. Glen Ayala's leadership and guidance made everyone fill safe and welcome to come to our community to play sports. Not only did Glen organize all of the sports programs, he still found time to manage Shamel Parks little league Dodgers that many of us had the pleasure to play for Glenn.

Glen Ayala was well respected by everyone in the community. With all of the turmoil, feuding, stealing, fighting and killings that were a part of our everyday lives, it was understood by everyone, Glen Ayala was of limits. Glen was solely responsible for fostering great relationships between the Latino American community and the African American community. If he had Angels tickets, he made sure to take members of both races with him. He made all of us feel equal and he gave us a sense of pride in our community and ourselves. I will always remember going to our schools within the Riverside Unified School District and listening to other kids and their families talk poorly about Casa Blanca and the kids that came from this community. We couldn't get rides home, we didn't get invited to birthday parties and the list goes on. However, we didn't feel sorry for ourselves because of the way Glen made us feel about our community. If your committee is deliberating on honoring this great man, they need not deliberate any longer. I attribute many of my successes in life to my family, my church and Glen Ayala. It is with great honor that I give my most sincere recommendation to honor Glen Ayala.

Should you need to have further conversation about Glenn, please do not hesitate to give me a call. Glen was a father figure to all of us regardless of race!

Currently, I am the Head Men's Basketball coach and Kinesiology Professor at Riverside City College and I can assure you that Mr. Ayala had a lot to do with inspiring me to become the leader that I have become just from being a product of the environment that he created.

This environment that I previously mentioned was not one that can be productive without the proper guidance. I grew up in the poverty-stricken neighborhood of Casa Blanca. To the outsider, this neighborhood was perceived as nothing but trouble, which it could be at times. However, there was one constant foundation for us all within the community, and that was Mr. Glen Ayala. Many of us grew up without a Father, A Mother, or without both parents in the home and needed direction. Mr. Ayala was instrumental in this aspect. During the summer time and even after school Mr. Ayala provided a safe and learning environment for us all at Villegas Park, located in the heart of Casa Blanca. Without the various leagues he set up year round, many of us, including myself would have found ourselves latching on and looking for trouble.

If you really want to know the true measure of Mr. Ayala's stature in our community, just look at where it is now. The "Black" and "Brown" race riots have spilled over into our community from the Prisons and is spreading like wild flowers. Mr. Ayala was instrumental in bringing us all together and putting us on the same teams and preaching cohesion and harmony throughout the community. Although, our neighborhood had its problems, race riots were not one of them. It saddens me to see it at the stage it is now, knowing how hard he worked on us all getting along.

Glen Ayala was and will always be the most inspirational "Father figure" that a lot of us from that community can remember and would like to hold on to. This is the reason why I am writing this letter. I would love to bring my kids back to Villegas Park and see a memorabilia of this great man in some fashion. Whether it be naming the Gymnasium after him or the Pool at the Park, however it is, I feel his name should be memorialized because of the impact and memories he created for us all.

Re: Naming of gymnasium at Villegas Park for Glen and Mary Ayala

When I first began working with families in the Casa Blanca neighborhood in the early 1970s, the names Glen and Mary Ayala were synonymous with constructive social action in the community. I worked with both Glen and Mary at various times from 1973 to the late 1980s.

I knew Glen as the director of the Villegas Community Center, where he not only organized constructive activities for youngsters in the community, but also established a positive relationship with many "at risk" youth. I believe that he was responsible for redirecting numerous young men away from self-destructive gang activity to positive community action. I know he was highly respected by the parents with whom I was working at the time.

Mary worked with me as a Community Aide in the Emergency School Aid Act (ESAA) program in the Riverside Unified School District when I served as an Intergroup Relations Specialist. She was invaluable to me and others in our program by connecting us to families who needed help understanding the importance of parent involvement in local schools. She frequently helped parents to overcome their fear of communicating with school teachers and administrators in RUSD, as we continued to develop programs to expand home-school communication after RUSD desegregated.. She continued to be an invaluable resource to me when I became a Counselor and Administrator at Arlington High School. I could always count on Mary to help connect with parents of students who were struggling in school. When I became an administrator at Poly High School, I could still count on Mary's help whenever I needed it.

Both Glen and Mary were outspoken advocates for families in the Casa Blanca community. They fought for parents' rights and citizens' rights with the school districts and the city. I always found them to be "pleasantly pushy" when dealing with authorities on any level. I believe that recognizing their contributions to Casa Blanca by giving their name to Villegas' gymnasium would be a fitting tribute to their activism.

As a resident of the Casa Blanca Community for over 65 years and a former employee of the City of Riverside, it my pleasure to acknowledge the efforts to two community leaders, Glen and Mary Ayala.

In September, 1958, I first met Glen and Mary Ayala. We became good friends over the years. Our children went to the same school at Casa Blanca Elementary. Together, Mary and I participated in PTA meetings and other social functions throughout the Casa Blanca community. Through community engagement and networking with other community leaders, we began to volunteer and plan neighborhood functions and community events for the youth and families in Casa Blanca. These functions included community parades, picnics, holiday carnivals, and several community services offered for the residents of the City at large. During this time, there was little to no engagement with the community or events such as these available for families and youth to enjoy.

Glen and Mary Ayala were always willing to help those in need. Through volunteer efforts and eventually as a Community Center Director, Glen and his family made an effort to provide services and activities for all community members regardless of their economic status. In many ways, Glen and Mary served as counsel to community members and helped guide them in any way possible. If they were unable to assist, they put them in contact with others who could. They played an essential role in "building community".

When Glen Ayala was hired by the City of Riverside Park and Recreation Department, I had the privilege of working with him as a preschool teacher. For over 20 years, our team worked together to provide programs for the residents of the community. Glen had a passion to serve and made it a priority to ensure that all youth (especially at-risk youth) had an opportunity to participate in activities provided to them as a method to keep them on a positive track. It was not uncommon to see Glen out on the playing fields, in the classrooms, even out on the streets encouraging youth to enroll in the programs offered at Ysmael Villegas Community Center. Volunteer groups comprised of parents, local business owners, and community members worked together to expand activities and events. Mary played an intrical role as a community liaison at community group and school group meetings, some of which include: Centro de Ninos, Head Start, Casa Blanca Home of Neighborly Services, etc.

The Ayala's were respected in the community. With little effort, they were able to engage people to volunteer for programs and lend a helping hand when needed. They were keen on making sure that things happened, a true definition of "doers". These attributes contributed to the many successful programs that occurred and have continued as a tradition in the community.

I miss my friends, their absence in the community has truly been a great loss. I cherish the memories of my friends and all of the community activities that we worked so hard to provide. We built community together a phrase which many Park and Recreation Departments have adopted over the years. In many ways, Glen and Mary Ayala were pioneers for many existing models for community service agencies throughout the city, county and state. Through good times, sad times and tough times, we all worked together as a team. Glen and Mary were true leaders in the community who had a profound impact in the City of Riverside. God bless them!


Mr. Ayala has worked hard and has been especially very dedicated to the youth in the area, and let's not forget his work for Park and Rec.

My name is Peter Garcia and I was born and raised in Casa Blanca. I would like to address this committee on behalf of Glen Ayala and his lifetime commitment to not only the community but to Villegas Park itself. I can speak of many occurrences that I have personally witnessed Glen involved with that have helped the community and the park and I am sure you have already heard many of them and quite possibly may have experienced some yourselves.

Please understand that it is not my intent to offend any person or family. There are many outstanding citizens from Casa Blanca that deserve to be honored and to be recognized. Unfortunately, not all of them will be given the opportunity to do so. But there are those who have dedicated themselves to the point where it is undeniable of their commitment to the citizens of the community and Glen Ayala is certainly one of them which is why he is one of the candidates being discussed today. I understand that Glen may not have been a recognized war veteran but I can say this, I personally witnessed how he maintained peace in the streets of Casa Blanca and stood at the front lines of our war torn barrio. He brought together many of the social clubs that the outside communities branded as gangs. I can recall that there was once a pool table in the little room of the gym in which Glen received donations from the social clubs and dedicated it to the kids of the community where I actually learned how to play the game. He once sat to speak to me about how power comes in numbers and that if the community would come together, it would have great power to make the difference for all of us that lived in our poverty stricken community. This was the main ingredient to his fight when he would address the counsels and fight for the programs that he instilled at the gym for the kids such as the haunted houses, turkey runs, and even having Santa flying in on a helicopter. As a result of this conversation I was persuaded as the leader of my club to put down the weapons and have a football game with an opposing club we were having trouble with at the time. He also advocated that instead of engaging in illegal activities to hold car washes or horseshoe tournaments to make the money it would take to buy our club jackets. He even allowed us to have the car wash at the gym and let us keep all the proceeds. I could go on and on and so could so many other people of this community and in this room but let me leave this topic to discuss another one.

I would like to take a little of your time to discuss both Mr. Villegas and Mr. Lara as well. It is my understanding that these brave men actually laid down their own lives for the democracy of our country. It only seems fitting to me that the democracy they fought for should be practiced not only in their living but also in their death. These are honorable men whose actions have displayed that they fought not only for their families but for everyone in this Country. It is written that there is no greater love than for one to give up his life for another. That shows the integrity of these men. So does it not make logical sense to say that if democracy was what they laid their life down for that it would be what they would want to see happen. I do not see these gentlemen as selfish men but rather men that believed in social equality for all. You have before you the people of the community voting for their family member and to have their loved one honored and rightfully so. Therefore I believe that the park should remain as Villegas Park, the bandstand or the Library should be named after Mr. Lara and the gymnasium itself should be named after Glen Ayala. After all we should take to honor what these men represented. I do not believe any of these men acted on behalf of pride of their name but rather lived by

their unselfish character that God blessed them with to be examples to those around them. 
**Attention Parks and Recreation,**

On behalf and my entire family, familia Velasquez of Casa Blanca, I am writing this letter in full support of the community's drive to rename part of the Villegas Park complex in honor of two of our most beloved residents, Mr. Glen and Mrs. Mary Ayala. My family has been in the Casa Blanca community since the late 1890s and can fully address the history of the community, including the role that the Ayalas played in the day-to-day activities of Casa Blanca. Mr. Ayala served as an exceptional manager of the gymnasium at Villegas Park for a long period of time, and constantly served as a role model for the many generations of youth that participated in the many sports activities at Villegas Park. I was one of those individuals who played basketball for about 15 years. I also participated in other sports activities including Little League. My family continues to participate, largely because of the programming first devised by Mr. Ayala.

Mrs. Mary Ayala was not only a civic rights activist for the community of Casa Blanca but also for the City of Riverside. During my years of growing up in Casa Blanca in the 1960s, and through many heated moments well into the 1980s, Mary and Glen were always there to monitor and guarantee that residents' civil rights were always protected. They were also at the forefront of helping the youth understand how the Vietnam war was affecting our community and how it was important to stand up for our beliefs as citizens of this country. She also worked with Cesar Chavez and the United Farm Workers during key moments when it was necessary to reign in support from Casa Blanca.

Personally, the Ayalas were always my role models for community organizing and activism and planted in me the ideals of helping our community to improve the quality of life for all residents, whether the residents were documented or not. The Ayalas served on several scholarship committees that provided funding for me to attend Harvard University for graduate school in the late 1970s. Their assistance and that of the community helped me complete my master's degree at Harvard, and then move on to my doctoral program at Arizona State University.

I fully support the drive from the community to rename part of the Villegas Park complex in honor of the Ayalas. Their mark in our community has remained all of these years even after their passing. It is time to honor their legacy as they always fought for political, social, and economic justice.


