

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CONFIRMING THE ANNUAL REPORT OF THE ARLINGTON BUSINESS PARTNERSHIP, ACTING IN ITS CAPACITY AS THE ADVISORY BOARD TO THE ARLINGTON BUSINESS IMPROVEMENT DISTRICT, LEVYING ASSESSMENTS FOR FISCAL YEAR 2022-2023.

WHEREAS the City Council of the City of Riverside by Resolution No. \_\_\_\_\_ stated its intention to amend boundaries and assessment amount of the district, to levy an annual assessment, and to hold a public hearing to consider protests to the annual levying of assessments for the Arlington Business Improvement District; and

WHEREAS the City Council has held a public hearing and heard, considered, and ruled on all written and oral protests to the imposition of the annual levy at said public hearing; and

WHEREAS the City Council has voted to reject the recommendation of the Advisory Board to amend the boundaries and to amend (increase) the assessment amount within the Arlington Business Improvement District,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to Section 36535 of the Streets & Highways Code, as follows:

1. The 2022-2023 annual report of the Arlington Business Partnership, acting in its capacity as the advisory board to the Arlington Business Improvement District, is confirmed.

2. The boundaries of the Arlington Business Improvement District shall remain how it currently stands and as described in Chapter 3.48 of the Riverside Municipal Code.

3. The levy for the Arlington Business Improvement District is imposed for the fiscal year 2022-2023, on each business within the Arlington Business Improvement District beginning November 1, 2022, at the rate of 90% of the non-discounted City of Riverside business tax charge, not to exceed \$400 per business.
