SUBJECT: RECEIVE AN UPDATE ON THE SOCIAL WORK INTERNSHIP PROGRAM

CALLED THE LOVE YOUR NEIGHBOR COLLABORATIVE ADMINSTERED BY

THE PATH OF LIFE MINISTRIES FROM JULY TO DECEMBER 2024

ISSUES:

Receive an update on the Social Work Internship Program called the Love your Neighbor Collaborative (LYNC) administered by the Path of Life Ministries from July to December 2024.

RECOMMENDATIONS:

That the Board of Library Trustees receive and discuss the Social Work Internship Program called the Love your Neighbor Collaborative (LYNC) program administered by the Path of Life Ministries.

LEGISLATIVE HISTORY:

On March 11, 2021, President Biden signed into law the American Rescue Plan Act to facilitate the recovery from the devastating economic and health effects of the COVID-19 pandemic. The American Rescue Plan Act (ARPA) established the Coronavirus State Fiscal Recovery Fund and Coronavirus Local Fiscal Recovery Fund, which provides a combined \$350 billion in assistance to eligible state, local, territorial, and Tribal governments to assist in the economic and health recovery by providing resources to address impacts resulting from the crisis.

ARPA established the Coronavirus Local Fiscal Recovery Fund to provide resources to support communities that are struggling with the impacts of COVID-19. These funds may be used to respond to pandemic response needs including mitigation and prevention, support to communities and populations most impacted by the COVID-19 crisis, and fill revenue shortfalls. The US Department of the Treasury first released Interim Final Rule providing eligibility guidance as well as regularly updated Frequently Asked Questions (FAQ). The Interim Final Rule provided initial guidance and served to help communities develop proposals for funding.

On November 9, 2021, the City Council approved the ARPA funding Expenditure Category Plan for the first allocation in the amount of \$36,767,594 following the Interim Final Rule guidelines, which included an allocation of \$450,000 for Public Health - Mental Health Support to create a Mental Health Resource Hub that provides services, counseling, programs in various languages

at no cost or reduced cost to residents facing mental health issues. City partnership between internal departments and local nonprofits. This resource hub can be used by the community at large and have focus areas that target highest needs populations, i.e., families, youth, homeless population, etc. Potential partners may include health providers and related nonprofit organizations. Including mental health programs at the Library. The Final Rule was issued on January 6, 2022, and became effective on April 1, 2022. The City received its first ARPA allocation of \$36,767,594 in June 2021 and is required to submit quarterly Project and Expenditure Reports and annual Recovery Plan Performance Reports.

BACKGROUND:

On January 10, 2023, the City Council approved the American Rescue Plan Act Subrecipient Agreement with Path of Life Ministries for \$200,000 of the American Rescue Plan Act funds for the Social Work Internship Program called Love your Neighbor Collaborative at eight (8) Riverside Public Library locations, and authorized the City Manager, or designee, to execute the American Rescue Plan Act Subrecipient Agreement with Path of Life Ministries, including making minor and non-substantial changes and contract extensions subject to availability of funding.

The Riverside Public Library serves many customers who are experiencing homelessness or other mental health challenges. Following best practices established throughout the United States including with the San Francisco Public Library, the Riverside Public Library identified the need for social workers to assist library customers experiencing homelessness and other mental health challenges in multiple library locations. To do this, the Library partnered with Path of Life Ministries to utilize their Social Work Internship Program, known as the Love Your Neighbor Collaborative (LYNC) that serves homeless individuals and families by utilizing undergraduate and graduate level social work students to connect them to crucial resources aimed at increasing their ability to become independent.

Path of Life Ministries will ultimately place social work interns at eight (8) library sites on a rotating basis, supervised by social work specialists. The interns will engage displaced individuals and refer them to agency partners to receive assistance for their mental, physical, behavioral, and spiritual needs. They will also engage in a needs assessment process alongside their supervisors and professors.

Interns' schedules, based on their academic calendars, will be determined based on the library sites' hours of operation. Interns will interface with displaced individuals at eight (8) libraries throughout Riverside to connect displaced individuals with various resources to improve their quality of life and to receive information about possible long-term housing options. The interns will be placed and supervised at the libraries for two years to work on meeting displaced individuals' crucial needs.

Based on the needs of the community, interns will be scheduled at the Arlington, SPC Jesus S. Duran Eastside, La Sierra, Main, and Marcy Library locations.

DISCUSSION:

On June 2023 the Love your Neighbor Collaborative (LYNC) launched the on-site phase of its program at the Main Library. On October 2, 2023, LYNC was expanded to the Arlington Library.

On February 13, 2024, the Board of Library Trustees received an update. LYNC is on-site Wednesday – Friday weekly the Riverside Main library location, Tuesday and Thursday weekly at the Arlington library and Tuesday and Wednesday weekly at the Specialist Jesus S. Duran Eastside library. LYNC serves individuals who organically frequent the library and receive services in response to either seeing flyers throughout the library that advertise the program, are referred by library staff, or encounter LYNC social workers due to crisis intervention assistance.

The following is a snapshot of outcomes the LYNC program has achieved from July to December 2024. It is important to note that these were the services documented due to individual's willingness to provide information for screening tools. These outcomes do not include other diversion services provided due to lack of willingness to further engage with LYNC social workers and provide identifying information.

The first amendment to an American Rescue Plan Act Subrecipient agreement was entered on August 13, 2024, to extend the term an additional twenty (20) months, effective July 1, 2024, through February 28, 2026, in the amount of \$241,340 for total compensation amount of \$441,340.
