
Errol Koshewitz spoke regarding Public Records request related to CalPERS expenditures.

CITY MANAGER UPDATE

The City Council received updates from the City Manager regarding (1) Mayor Lock Dawson, Councilmember Robillard, and Community and Economic Development Director Jennifer Lilley in Washington, DC attracting new business to the City of Riverside and lobbying efforts in Washinton, DC; (2) meetings with EPA to discuss water utility issues and with FAA to discuss our regional airport; and (3) a Riverside Cohort consisting of City Manager, Mayor Lock Dawson, Fire Chief McKinster and Advisor to the Mayor Zoe Ridgway, chosen by Harvard Kennedy School of Business and sponsored by Bloomberg Foundation, will be traveling to Boston for training focused on community engagement regarding wild fire prevention and what to do after a fire.

AMENDMENT - PROPOSED FISCAL YEAR 2025-2026 - FISCAL YEAR 2024-2026 BIENNIAL BUDGET

Following discussion, it was moved by Councilmember Cervantes and seconded by Councilmember Perry to (1) receive and file the proposed amendment of Fiscal Year 2025/26 of the previously adopted Fiscal Year 2024-2026 Biennial Budget; and (2) set a public hearing for the adoption of the Amended Fiscal Year 2025/26 Budget on June 17, 2025. The motion carried unanimously.

CONSENT CALENDAR

It was moved by Councilmember Hemenway and seconded by Councilmember Perry to approve the Consent Calendar as presented affirming the actions appropriate to each item. The motion carried unanimously.

MINUTES

The minutes of the meeting of April 29, 2025, were approved as presented.

GRANT AGREEMENT - ARMORY BUILDING AT FAIRMOUNT PARK - SUPPLEMENTAL APPROPRIATION

The City Council (1) authorized the acceptance of two million five hundred thousand dollars (\$2,500,000) from a federal subcommittee appropriation to support the substantial renovation of the Armory Building at Fairmount Park; (2) approved a draft Grant Agreement with the U.S. Department of Housing and Urban Development (HUD) as the administering document for the federal subcommittee appropriation related to this Project; (3) authorized the City Manager or designee to execute any and all funding documents associated with receipt and usage of this funding appropriation, making minor corrections as necessary; and (4) upon execution of a final Grant Agreement with HUD, authorized an increase in revenue to the Grants and Restricted Programs fund, Armory Renovations project account and corresponding appropriation to an expenditure account in the amount of \$2,500,000 or the actual grant award to be established by the Finance Department.

REQUEST FOR PROPOSAL 2439 AGREEMENT - 2022 REGIONAL EARLY ACTION PLANNING (REAP 2) GRANT HOUSING INFILL ON PUBLIC AND PRIVATE LANDS (HIPP) PILOT PROJECT

The City Council (1) approved a Professional Consultant Services Agreement with RADAR Inc., Los Angeles, for Request for Proposal (RFP) No. 2439, for the Missing Middle Prototype Plans for Infill Housing Sites Project, for a one-year term with an optional one-year extension in the amount of \$472,993 and a change order authority in the amount of \$27,007 not to exceed a total compensation amount of \$500,000; and (2) authorized the City Manager, or his designee, to execute the Professional Consultant Services Agreement and subsequent related agreement(s), as necessary, with RADAR Inc, including making minor and non-substantive changes including but not limited to exercising the option to extend.

GRANT FUNDS - MULBERRY GARDEN FAMILY PROJECT - SUPPLEMENTAL APPROPRIATION - RESOLUTION

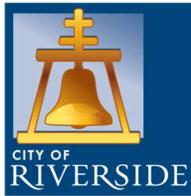
The City Council (1) adopted a resolution authorizing a joint application with the City of Riverside and Eden Housing, Inc. and acceptance of a grant award of \$27,974,220 from the State of California Department of Housing and Community Development for a \$14,000,000 Affordable Housing and Sustainable Communities loan for the development of the Mulberry Gardens Family Apartments located at 2524 Mulberry Street and a \$13,974,220 grant for the associated Sustainable Transportation Infrastructure projects; (2) authorized the City Manager, or designee, to sign any documents that may be required for submittal of the Affordable Housing and Sustainable Communities application, including making minor and non-substantive changes; (3) accepted a grant award in the amount of \$13,974,220 from the State of California Affordable Housing and Sustainable Communities Grant for transportation projects awarded under the Mulberry Gardens Family Project; and (4) authorized the Chief Financial Officer, or designee, to record an increase in revenue and an appropriation in the amount of \$13,974,220, or the actual grant award, in the Development Grants Fund, AHSC Mulberry Gardens – Mulberry Gardens Family Project revenue and expenditure accounts; whereupon the title having been read and further reading waived, Resolution No. 24260 of the City Council of the City of Riverside, California, Authorizing the Acceptance of Grant Funds from the Department of Housing and Community Development for the Affordable Housing and Sustainable Communities for the Mulberry Garden Family Project and Associated Sustainable Transportation Improvement Projects("STI").

AGREEMENT - COMMERCIAL DRIVER'S ENTRY-LEVEL DRIVER TRAINING SERVICES

The City Council (1) approved a Professional Consultant Services Agreement with Rock Gate Capital LLC., Chicago, Illinois, to provide Employee Commercial Driver's Entry-Level Driver Training Services for a three-year term through June 30, 2028 totaling \$300,000, with the option for two one-year extensions, in an amount not-to-exceed \$100,000 annually, for a total contract amount of \$500,000 if options are exercised; and (2) authorized the City Manager, or his designee, to execute the Professional Consultant Services Agreement with Rock Gate Capital LLC., including making minor and no substantive changes and also execute future contract extensions as provided for in the Agreement.


City Attorney Rebecca Reibold-McKee announced there were no reportable actions taken.
