## 1 ORDINANCE NO. 2 AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTION 10.56.020 OF THE **RIVERSIDE** MUNICIPAL 3 DESIGNATING THE RESTRICTION OF COMMERCIAL VEHICLES FOR CERTAIN STREETS AND PORTIONS THEREOF TO REVISE THE 4 ADOPTED 5-TON WEIGHT LIMIT RESTRICTIONS ON FAIR ISLE DRIVE 5 AND LOCHMOOR DRIVE. 6 The City Council of the City of Riverside does ordain as follows: 7 Section 1: Section 10.56.020 of the Riverside Municipal Code, is hereby amended to 8 read as follows: 9 Section 10.56.020 Commercial vehicles exceeding Ten Thousand 10 pounds (5 Tons) gross weight prohibited from using 11 certain streets. 12 When signs are erected giving notice thereof, no person shall operate any commercial vehicle exceeding Ten Thousand pounds (5 tons) gross weight 13 at any time upon any of the streets or parts of streets listed below, except 14 that such vehicle may be operated thereon for the purpose of delivering or picking up materials or merchandise or the performance of services in 15 connection with and in aid of a property in the block, and then only by entering such street at the intersection nearest the destination of the vehicle 16 and proceeding thereon no farther than the nearest intersection thereafter, 17 and except as provided in Section 10.56.030: 18 **Exceeding Ten Thousand Pounds (5 Tons) Gross Weight:** 19 **Name of Street Limits of Prohibition** 20 Arch Way Central Avenue and Sierra Street 2.1 Bandini Avenue Magnolia Avenue and Olivewood Avenue 22 **Barton Street** Van Buren Boulevard and Orange Terrace Parkway 23 Brockton Avenue and Palm Avenue **Beatty Drive** 2.4 25 Beechwood Place Magnolia Avenue and Ramona Drive **Brockton Avenue** Seventh Street and First Street 26 27 **Burge Street** Magnolia Avenue and Starlight Court

10	hereby finds that this ordinance is not subject	et to CEQA pursuant to Sections 15060(c)(2),	
11	15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations,		
12	Title 14, chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical		
13	change in the environment nor have a significant impact on the environment. Furthermore,		
14	pursuant to Section 15301(c), it is exempt from further review as an operation, repair,		
15	maintenance, permitting, leasing, licensing, or minor alteration of an existing public street.		
16	Section 3: The City Clerk shall certify to the adoption of this ordinance and cause		
17	publication once in a newspaper of general circulation in accordance with Section 414 of the		
18	Charter of the City of Riverside. This ordinance	e shall become effective on the 30th day after the	
19	date of its adoption.
