

THIRD AMENDMENT TO AGREEMENT  
FOR THE YOUTH SPORTS OFFICIALS AND SCOREKEEPERS

DANNY FULLER DBA SPORTS INNOVATORS

THIS THIRD AMENDMENT TO AGREEMENT FOR THE YOUTH SPORTS OFFICIALS AND SCOREKEEPERS ("Third Amendment") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2025, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and DANNY FULLER, a sole proprietor, doing business as SPORTS INNOVATORS ("Contractor"), with respect to the following:

**RECITALS**

WHEREAS, the City and Contractor entered into that certain Agreement for the Youth Sports Officials and Scorekeepers, dated January 1, 2023 ("Agreement"); and

WHEREAS, the City and Contractor entered into that certain First Amendment for the Youth Sports Officials and Scorekeepers, dated January 1, 2024 ("First Amendment"); and

WHEREAS, the City and Contractor entered into that certain Second Amendment for the Youth Sports Officials and Scorekeepers, dated February 7, 2025, ("Second Amendment"); and

WHEREAS, the City desires to have Contractor continue providing the services referenced in that Agreement; and

WHEREAS, the City and Contractor desire to amend the Agreement to extend the term of the Agreement to December 31, 2026, using the third one-year extension option; and

WHEREAS, the City and Contractor desire to amend the compensation schedule and increase compensation in the amount of Thirty Three Thousand Nine Hundred Fifty Dollars (\$33,950.00), for the extended term of the Agreement.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

1. Section 3, Term, is hereby amended to extend the term of the Agreement to December 31, 2026.

2. Section 4, Compensation/Payment, is hereby amended in its entirety and replaced by the following:

"Section 4. **Compensation.** The City shall compensate the Contractor for the services herein provided as follows: For providing two (2) officials for each basketball game at Thirty Dollars (\$35) per game per official. For providing two (2) officials for each flag football game at Thirty Dollars (\$35) per game per official. In the event the Contractor

provides only one (1) official for any game requiring two (2) officials, and the game is not cancelled, the City shall pay to Contractor the sum of Forty Dollars (\$40) for such official. The amount to be paid to Contractor pursuant to this Agreement shall not exceed the amount of Thirty Three Thousand Nine Hundred Fifty Dollars (\$33,950).”

3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
