

**SECOND AMENDMENT TO THE
AGREEMENT FOR
PROFESSIONAL SERVICES
(Adult/Adolescent Forensic Services)**

This Second Amendment to the Agreement for Professional Services (Adult/Adolescent Forensic Services) (Second Amendment), is entered into by and between the City of Riverside (CITY), a municipal corporation of the State of California, on behalf of the Riverside Police Department, (herein referred to as "RPD") and the County of Riverside (COUNTY), a political subdivision of the State of California, on behalf of the Riverside University Health System – Medical Center (herein referred to as "RUHS-MC"), sometimes collectively referred to herein as the "Parties" or individually referred to as a "Party."

WHEREAS, COUNTY and CITY have entered into that certain Agreement for Adult/Adolescent Forensic Services, effective November 15, 2022, through June 30, 2023, with two (2) one-year options to renew by written amendment, (Agreement), whereby RUHS-MC agreed to provide RPD with professional services in the specialty practice of Adult/Adolescent Forensic Services (SPECIALTY); and,

WHEREAS, COUNTY and CITY have entered into that First Amendment of the Agreement for Adult/Adolescent Forensic Services, effective September 1, 2023 through June 30, 2024, with one (1) one-year options to renew by written amendment, (Agreement), to reinstate the Original Agreement so that it may be amended and extended to allow the Parties to perform their respective obligations under the Original Agreement and to extend the Term by exercising a renewal option set forth in the Original Agreement; and,

WHEREAS, COUNTY and CITY desire to amend the Agreement to extend the Term by exercising the final renewal option set forth in the Agreement;

NOW THEREFORE, the Parties agree as follows:

1. Period of Performance. **Section 2.1 Period of Performance** is hereby amended to read as follows:

"This Agreement shall be effective July 1, 2024 and continues in effect through June 30, 2025, unless terminated earlier."
2. Miscellaneous. All other terms and conditions of this Agreement are to remain unchanged.
3. Effective Date. This Second Amendment to the Agreement shall become effective July 1, 2024.
4. This Amendment may be executed in any number of counterparts, each of which will be an original, but all of which together will constitute one instrument. Each Party to this Amendment agrees to the use of electronic signatures, such as digital signatures that meet the requirements of the California Uniform Electronic Transactions Act ("CUETA") Cal. Civ. Code §§ 1633.1 to 1633.17), for executing this Amendment. The Parties further agree that the electronic signatures of the Parties included in this Amendment are intended to authenticate this writing and to have the same force and effect as manual signatures. Electronic signature means an electronic sound, symbol, or process attached to or logically associated with an electronic record and executed or adopted by a person with the intent to sign the electronic record pursuant to the CUETA as

amended from time to time. The CUETA authorizes use of an electronic signature for transactions and contracts among parties in California, including a government agency. Digital signature means an electronic identifier, created by computer, intended by the Party using it to have the same force and effect as the use of a manual signature, and shall be reasonably relied upon by the Parties. For purposes of this section, a digital signature is a type of "electronic signature" as defined in subdivision (i) of Section 1633.2 of the Civil Code.
