

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, RELATING TO CALPERS
4 RETIREMENT COST-SHARING UNDER GOVERNMENT CODE
5 SECTION 20516 BY UNREPRESENTED POLICE MANAGEMENT
6 EMPLOYEES IN THE POLICE SAFETY GROUP.

7 WHEREAS, unrepresented Police Management employees of the Police Safety group of
8 the City of Riverside ("City") are not covered by a memorandum of understanding; and

9 WHEREAS, changes to wages and benefits for unrepresented Police Management
10 employees of the Police Safety group are recommended by the City Manager and approved by
11 the City Council; and

12 WHEREAS, the City is interested in having all Classic, Tier 1 and Tier 2, unrepresented
13 Police Management employees in the Policy Safety group participate in employee cost sharing
14 towards the CalPERS retirement benefits pursuant to Government Code Section 20516; and

15 WHEREAS, CalPERS requires that the City Council adopt a resolution that specifically
16 identifies the following information for unrepresented employees in order to initiate the process
17 for the City to amend its CalPERS contract to provide for Section 20516 (Cost Sharing) as
18 follows:

- 19 • Unrepresented Cost Share Percentages to become effective as soon as
20 administratively possible with CalPERS:

- 21 a) 5.5% for Classic, Tier 1 and Tier 2, Unrepresented Police Management
22 employees of the Police Safety group

23 WHEREAS, a majority of the unrepresented Police Management employees of the Police
24 Safety group impacted by this cost-sharing amendment have signed this resolution as shown on
25 Exhibit "A" attached hereto and incorporated by reference.

26 NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Riverside,
27 California, as follows:
28

Section 1: That the above recitals are found to be true and correct and are hereby incorporated as if stated in full.

Section 2: That this resolution complies with CalPERS' procedures for unrepresented employees needed in order to initiate the employee CalPERS contract amendment process under Government Code Section 20516.

Section 3: That the City Council approves this resolution to initiate the employee CalPERS contract amendment under Government Code Section 20516 for Classic, Tier 1 and Tier 2, Unrepresented Police Management employees of the Police Safety group.

Section 3: That this resolution shall become effective as soon as administratively possible.
