Chair Friedlander called the meeting to order at 6:30 p.m. and led the pledge of allegiance.

PUBLIC COMMENT

PRESENTATIONS

REID PARK CHEER RECOGNITION

Recreation Superintendent Jessica Ochoa formally congratulated the Reid Park Cheer on a job well done and thanked them for representing the City of Riverside with energy and pride. Also presented recognition to Coach Amber Graham.

RECREATION DIVISION SPRING EVENTS UPDATE

Recreation Superintendent Jessica Ochoa presented the Recreation Division Spring Events update.

Commissioner Barlogio asked how many of the parks have an Advisory Board/Committee, and what do the Advisory Board/Committees provide.

Recreation Superintendent Ochoa stated that there are 9 advisories. Not all parks have one. Advisory Boards/Committees provide guidance and fund raise for events.

PATTERSON PARK UPDATE

Project Manager Maus stated it will be natural grass.

Commissioner Kopp asked if the rubberized track is the same material used on the playgrounds.

Project Manager Maus stated that it is different material.

Commissioner Dawson asked what would be done with the old equipment.

Project Manager Maus stated some items will be retained by Parks Division for reuse. Everything else will be taken off site and demolished.

Commissioner Dawson asked if the department has staff members that are certified for playground equipment inspection.

Project Manager Maus stated the department does have certified staff.

Commissioner Dawson asked if the new lighting is dark skies compatible.

Project Manager Maus stated the lighting will all be adjusted and focused to reduce the light pollution into adjacent properties.

Commissioner Dawson asked what the life expectancy of the rubberized track and the rubber around the playground equipment was.

Project Manager Maus stated that the standard warranty is 8 to 10 years for both.
