8 PLANNING CASE DP-2024-01600 (HD): Proposal by Riverside Housing Development Corporation on behalf of Orange Valley Masonic Lodge #13 to consider a Historic Designation request for designation of Mercantile Hall as a City Landmark. The property is located at 2933 Twelfth Street, on the north side of Twelfth Street between Howard and Park Avenues, in Ward 1.
