All Districts. {Total Cost \$4,000,000, with up to \$700,000 in additional compensation, 100% Sheriff budget}

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve amendments to the Professional Service Agreements with the Vendors Listed in Attachment A (Approved Contract Vendor List) for various background investigation services and increase the total contract amount by \$4,000,000 for a total aggregate amount of \$7,000,000 and continue in effect through June 30, 2025, unless terminated earlier.
2. Authorizing Purchasing Agent, in accordance with Ordinance 459, based on the availability of fiscal funding and as approved by County Counsel: (a) to sign amendments that exercise the options of the agreement including modifications of the statement of work that stay within the intent of the Agreement; (b) move the allocated funds among the vendors; (c) and sign amendments to the compensation provisions that do not exceed the sum total of ten percent (10%) of the total annual cost of the contract.



BACKGROUND:

Summary

The Form 11 previously approved on September 17, 2019 (Agenda 3.16), gave authority to conduct a thorough background investigation check as a necessary and important component of any law enforcement application process. The sensitive nature of the law enforcement work, combined with the high level of trust and authority that the public gives to these professionals, requires that candidates be of the highest moral character. The Riverside County Sheriff's Department employs multi-screening procedures including medical, psychological, physical fitness, interview panels and the background investigation in their process to ensure we select the best applicants, and applicants with criminal pasts or current involvements are filtered out.

Background checks for law enforcement officers are a very time consuming and labor-intensive process that can take up to nine (9) months to complete. While the previous goal was revised to have each background, check completed within 180 days, the current Sheriff's Administration aims to have each background check completed within 100 days. This change reflects the Department's goal to fill approximately 400 positions in the coming years to staff the opening of the John Benoit Detention Center (JBDC), and other critical need positions throughout the County. With this hiring objective, the Department needs to have multiple approved vendors to provide the background investigation services to support and expedite our recruitment efforts in a reasonable and timely manner. In addition to the pre-employment background investigation services, many of these selected vendors can also provide disciplinary investigations into allegations of employee's misconduct, and background check of citizens applying for their Carry Canceled Weapon (CCW) permit on as-needed basis.

The Riverside County Sheriff's Department is asking to increase the total contract aggregate amount by \$4,000,000. The previous Form 11 was approved for a total aggregate amount of \$3,000,000. The increased amount will bring the total aggregate amount to \$7,000,000.

In addition, the Department is requesting for a 10% contingency of the total contract amount, which is \$700,000, to allow for additional labor expenses. The total six-year cost with the 10% contingency is \$7,700,000.

Impact on Residents and Businesses

A thorough background investigation is important to ensure the applicants selected not only have the aptitude, but also the necessary moral fiber to carry a gun and a badge to protect and serve the communities. With the increasing departmental liability, employing multiple pre-screening procedures will allow the Department to select the most qualified applicants to serve the public and communities.

Price Reasonableness

The Riverside County Purchasing Fleet Department, on behalf of the Riverside County Sheriff's Department, released a Request for Proposal (RFP # SHARC-404) for independent investigative services of law enforcement pre-employment, personnel for disciplinary and misconduct matters, and background investigation on public applicants requesting for their Carry Concealed Weapon (CCW) Permits. The RFP was advertised on the County's Internet and the bid invitation was sent to fifty-two (52) potential bidders, thirty-eight (38) of them downloaded the bid, and twelve (12) vendors submitted their proposal. The proposals were reviewed by the team consisting of the Sheriff Personnel in which each bid response was evaluated based on the criteria set forth in the RFP: overall responses to the RFP requirements, bidders experience and technical ability, references, and financial.

As the result of the bid evaluation process, the committee selected ten vendors to build their master list of approved contract vendors for these three services to be used on an "as needed" basis. Based on FY 17/18 case load, the Department conducted approximately 2,600 pre-employment background investigations: 325 internal affairs investigations and over 1,000 CCW investigations. The Department projects the number for background investigations will increase substantially since the Department is ramping up our recruitment efforts. Based on these numbers, the Department would like the option to have multiple vendors for each service to allow for immediate support base on the department's volume and specific needs. Currently there are nineteen sworn personnel assigned to perform background investigations at a cost of \$2.8M in salaries and benefits annually. Using third party vendors for these services will reduce cost of the salary and benefit, which is a cost saving to the County. Furthermore, the department plans to redeploy existing sworn personnel back to their field assignments.
