THIS FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("First Amendment") is made and entered into this      day of                     , 2021, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and INLAND EMPIRE OCCUPATIONAL MEDICAL GROUP, INC., a California corporation ("Consultant"), with respect to the following:

**RECITALS**

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated June 24, 2019 ("Agreement"), for Pre-Employment Services ("Project"); and

WHEREAS, the City has been satisfied with Consultant's performance under the Agreement and desires to have Consultant continue providing the services referenced in that Agreement; and

WHEREAS, the Agreement is currently set to expire on June 30, 2021; and

WHEREAS, the City and Consultant desire to amend the Agreement to extend the term for one (1) additional year to June 30, 2022, and increase compensation during the extended term to One Hundred Eight Thousand Three Hundred Dollars (\$108,300.00) annually.

NOW, THEREFORE, incorporating the recitals, which are incorporated herein by this reference, City and Consultant agree as follows:


1. Section 2, Term, is hereby amended to extend the term of the Agreement for one year, to June 30, 2022.
2. Section 3, Compensation/Payment, is hereby amended to increase the compensation for the annual amount to One Hundred Eight Thousand Three Hundred Dollars (\$108,300.00) annually, during the extended term of the Agreement
3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.

IN WITNESS WHEREOF, the parties hereto have caused this First Amendment to Professional Consultant Services Agreement to be duly executed the day and year first above written.


