

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO.
4 21052 TO AMEND THE MASTER FRINGE BENEFITS AND
5 SALARY PLAN FOR SALARY ADJUSTMENTS TO THE
6 EXISTING FIRE MECHANIC, BUSINESS TAX COLLECTIONS
7 SUPERVISOR AND UTILITIES PRINCIPAL PROGRAMS AND
8 SERVICES REPRESENTATIVE CLASSIFICATIONS.

9 WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council
10 thereby adopting the Master Fringe Benefits and Salary Plan (“FBSP”); and

11 WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;
12 and

13 WHEREAS, the FBSP has been amended several times to update the benefits and
14 salaries; and

15 WHEREAS, adjusting the salary ranges for the existing Fire Mechanic, Business Tax
16 Collections Supervisor, and Utilities Principal Programs and Services Representative
17 classifications has been proposed; and

18 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the proposed
19 changes.

20 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as
21 follows:

22 Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are
23 hereby amended to adjust the salary ranges for the existing Fire Mechanic, Business Tax
24 Collections Supervisor, and Utilities Principal Programs and Services Representative
25 classifications as set forth in Exhibit “A” attached hereto and incorporated herein by reference.

26 Section 2: Authorize the City Manager, or his designee, to make minor, non-
27 substantive changes to the Master Fringe Benefits and Salary Plan and any related policies,
28 procedures or documents necessary to implement these provisions

Section 3: The provisions of this resolution shall be operative upon adoption.
