REVIEW OF COMMUNITY POLICE REVIEW COMMISSION (CPRC) MEMBERSHIP STRUCTURE Following discussion, and without formal motion, the Community Police Review Commission (1) received and ordered filed the report on CPRC membership structure, roles, potential consolidation opportunities and the development of a Citywide governance resolution; and (2) provided suggestions regarding the timing of on-boarding for new members and training.

SCHEDULE PROPOSED FULL-DAY TRAINING OPTIONS ON VARIOUS POLICE PROCEDURES Following discussion, it was moved by Commissioner Ferguson and seconded by Commissioner Ward to select July 22, and July 31, for police training sessions covering Shoot/Don't Shoot Scenarios, Searches and Arresting Techniques, Best Practices for Conducting Traffic Stops, Taser Use and Presentation, and De-escalation Techniques and Process. The motion carried unanimously with Commissioner Garcia absent.

Following further discussion, commissioners committed to attending on July 22, are Chair Bell and Commissioners Ward and Lundy; and on July 31, they are Vice Chair Gutierrez and Commissioners Ferguson and Teichert.

REVIEW STAGE 2 OF THE CRIMINAL CASE BOOK FOR OFFICER INVOLVED DEATH CASE #2022-00362 AND #MB22 019 0001 - J. TRACY

Community Police Review Commission Independent Consultant Frank Hauptmann opened the review of Stage 2 of the Criminal Case Book for Officer Involved Death Case #2022-00362 and #MB22 019 0001 - J. Tracy. Mr. Hauptmann provided the Commission with an update regarding the public records requests submitted to the Riverside County Sherriff and Hemet Police Department requesting body worn camera videos, Closed Circuit Television videos, and photos pertaining to OID involving J. Tracy and the option of using the Commission's subpoena powers to obtain the records.

Following discussion, it was moved by Commissioner Teichert and seconded by Commissioner Ward requesting that the City Attorney's Office prepare a subpoena for the records from the Riverside County Sherriff and Hemet Police Department. The motion carried unanimously with Commissioner Garcia absent.

Following further discussion, it was moved by Commissioner Teichert and seconded by Commissioner Dillon to conclude Stage Two - Fact Finding, Request for Training & Investigation of the Officer Involved Death case #2022-00362 and MB22 019 0001 - J. Tracy and begin Stage Three - Policies and Procedures Process. The motion carried unanimously with Commissioner Garcia absent.
