Following discussion, it was moved by Member Perry and seconded by Vice Chair Hemenway to recommend that the City Council (1) approve and adopt the 2023 Integrated Resource Plan for Riverside Public Utilities; and (2) direct staff to file the adopted 2023 Integrated Resource Plan (2023 IRP) and any applicable supporting material with the California Energy Commission within five (5) business days after adoption of the 2023 IRP. The motion carried unanimously.

transition plan; (4) collaboration with other departments to submit an Extreme Heat Grant application for improvements to the Arlanza and Casa Blanca Community Centers; (5) a grant application to the Environmental Protection Agency grant in the Casa Blanca community for pedestrian, bicycles, walkability, traffic calming, and possibly speed humps improvements; (6) on-going paving work on Magnolia Avenue and Alessandro Boulevard; and (7) renewal process for preferential parking zones.

Public Works Deputy Director Lee Withers provided updates regarding (1) the first cabinet wrap project at Magnolia Avenue and Pierce; and (2) a coordination meeting with Riverside Public Utilities Water to support them with 1200 linear feet of trench patching on an upcoming waterline project on Market Street between Eleventh and Fourteen Streets.

Public Works Director Gil Hernandez provided updates regarding (1) Casa Blanca Community Action Group meeting; (2) the upcoming Van Buren Sewer Project in collaboration with the County of Riverside that will include paving work; and (3) a visit to Irvine for the CicloIrvine event that encouraged an increase biking and walking.
