

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, FOR FUNDING FROM THE URBAN AND  
4 COMMUNITY FORESTRY GRANT PROGRAM OF THE CALIFORNIA  
DEPARTMENT OF FORESTRY AND FIRE PROTECTION.

5 WHEREAS, the Governor of the State of California, in cooperation with the State  
6 Legislature, has appropriated General Funds for the State's urban forestry programs; and

7 WHEREAS, the State Department of Forestry and Fire Protection has been delegated the  
8 responsibility for the administration of the program within the State, setting up necessary procedures  
9 governing application by local agencies and non-profit organizations under the program, and

10 WHEREAS, said procedures established by the Department of Forestry and Fire Protection  
11 require the applicant to certify by resolution the approval of application before submission of said  
12 application to the State; and

13 WHEREAS, the applicant will enter an agreement with the State of California to carry out an  
14 urban forestry project.

15 NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Riverside,  
16 California:

17 Section 1: Approved the filing of an application for the Urban and Community Forestry grant  
18 program funds; and

19 Section 2: Certifies that said applicant has or will have sufficient funds to operate and  
20 maintain the project; and

21 Section 3: Certifies that funds under the jurisdiction of the City of Riverside are available  
22 to begin the project; and

23 Section 4: Certifies that said applicant will expend grant funds prior to March 31, 2028; and

24 Section 5: Appoints the City Manager, or a designee, as agent of the City of Riverside to  
25 conduct negotiations, execute and submit all documents including, but not limited to, applications,  
26 agreements, amendments, payment requests and so on, which may be necessary for the completion  
27 of the aforementioned project.
