2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO.  
4 21052 AND THE MASTER FRINGE BENEFITS AND SALARY  
5 PLAN TO APPROVE THE SALARY ADJUSTMENTS TO THE  
6 EXISTING ADMINISTRATIVE ANALYST, MANAGEMENT  
7 ANALYST AND FINANCIAL ANALYST SERIES; APPROVE  
8 AN ADDITIONAL STEP FOR THE SENIOR MECHANIC  
9 CLASSIFICATION; DELETION OF NON-UTILIZED  
10 CLASSIFICATIONS; AND APPROVE ADDITIONAL FIVE  
11 PERCENT SPECIAL COMPENSATION FOR CNG FUEL  
12 ISLAND ASSIGNMENT.

13 WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council  
14 thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and

15 WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;  
16 and

17 WHEREAS, the FBSP has been amended several times to update the benefits and  
18 salaries; and

19 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the salary  
20 adjustments for the existing classifications within the Administrative Analyst, Management  
21 Analyst and Financial Analyst series; and

22 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect an additional  
23 step for the Senior Mechanic classification and deletion of the Senior Mechanic Specialist  
24 classification.

25 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as  
26 follows:

27 Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are  
28 hereby amended Warehouse Supervisor to 1) approve the salary adjustments for the existing  
classifications within the Administrative Analyst, Management Analyst and Financial Analyst  
series; 2) approve an additional step for the Senior Mechanic classification and deletion of the  
Senior Mechanic Specialist classification; and 3) approve an additional five percent (5%) special  
compensation for employees in the Fire Mechanic, Mechanic, and Senior Mechanic

1 classifications when assigned to the CNG fuel island, all as set forth in Exhibit "A" and Exhibit  
2 "B" attached hereto and incorporated herein by reference.

3 Section 2: Authorize the City Manager, or designee, to make minor, non-substantive  
4 changes to the Master Fringe Benefits and Salary Plan and any related policies, procedures or  
5 documents necessary to implement these provisions.

6 Section 3: The provisions of this resolution shall be operative upon adoption.
