Mayor Pro Tem Conder called the meeting to order at 1:00 p.m.


Councilmember Perry gave the invocation and led the Pledge of Allegiance.



The motion carried unanimously.

LEGAL BUDGET INCREASE - CITY ATTORNEY LEGAL FEES - SUPPLEMENTAL APPROPRIATION
The City Council (1) approved an increase to the legal budget for the law firm of Colantuono, Highsmith & Whatley in an amount not-to-exceed \$83,000 for a revised total budget of \$499,400 for Lawsuit entitled Simpson v. City of Riverside; and (2) authorized the Chief Financial Officer, or designee, to record a supplemental appropriation in the amount of \$83,000 in the General Fund, City Attorney Outside Legal Services account. Councilmember Conder voted no.

RIVERSIDE MUNICIPAL CODE AMENDMENT - ORDINANCE ADOPTED

The City Council adopted an Ordinance amending Riverside Municipal Code Sections 1.17.121(A) and 9.40.120 regarding uniform appeal process for Junk Dealer and Scrap metal Recyclers and Adult-Oriented Businesses.



COURTHOUSE EXPANSION - UNITED STATES DISTRICT COURTHOUSE CENTRAL DISTRICT - EASTERN DIVISION

The City Council (1) supported the expansion of the United States District Courthouse Eastern Division of the Central District of California, located in Riverside County; and (2) directed City Manager to identify stakeholders and coordinate advocacy for federal funding of United States General Services Administration (GSA) Phase One Feasibility Study for implementation of Long-Term Facilities Plan for courthouse expansion.


DESIGN PHASE OF RUNWAY 9-27 SAFETY AREA EROSION CONTROL PROJECT - RIVERSIDE MUNICIPAL AIRPORT - RESOLUTION - SUPPLEMENTAL APPROPRIATION

The City Council (1) adopted a Resolution authorizing receipt of a \$283,366 grant from the Federal Aviation Administration to the City of Riverside for the design phase of Runway 9-27 Runway Safety Area Erosion Control project at Riverside Municipal Airport; (2) upon grant award from the Federal Aviation Administration, authorized an increase in revenues in the amount of \$283,366 an appropriation of expenditures in an equal amount to the applicable grant accounts in the Airport Fund, Erosion Control Project revenue and expenditure accounts; and (3) authorized the City Manager, or his designee, to execute a grant agreement with the Federal Aviation Administration, including making minor and non-substantive changes.

Whereupon, the title having been read and further reading waived, Resolution No. 24311 of the City Council of the City of Riverside, California, Authorizing the Application and Acceptance of Grant Funds from the Federal Aviation Administration for the Design Phase of Runway 9-27 Runway Safety Area Erosion Control Project at the Riverside Municipal Airport; and Authorizing the Execution of all Necessary Documents Related to Such Grant, was presented and adopted.



DOWNTOWN PARKING AND BUSINESS IMPROVEMENT AREA - PUBLIC HEARING SCHEDULED - RESOLUTION

The City Council (1) received and approved the Annual Report of the Riverside Downtown Partnership, acting in its capacity as the Advisory Board to the Downtown Parking and Business Improvement Area; (2) adopted a Resolution declaring the City of Riverside's intention to levy and collect an annual assessment in the Downtown Business Improvement Area for Calendar Year 2026, from January 1, 2026, through December 31, 2026; and (3) set a public hearing for December 2, 2025, at 3:00 p.m. on the levy of the proposed assessment.


AGREEMENT - BUSINESS LICENSE, TRANSIENT OCCUPANCY TAX, SHORT-TERM RENTAL, AND UTILITY USER TAX SERVICES

The City Council (1) approved an Agreement for Business License, Transient Occupancy Tax, Short-Term Rental, and Utility User Tax Services with Hinderliter, de Llamas and Associates (HdL), starting on October 25, 2025, for a one-year term for a not-to-exceed amount of \$340,000 with an option to extend one year for a not-to-exceed amount of \$370,000; and (2) authorized the City Manager, or his designee, to execute the Agreement, issue a notice of termination when applicable, execute extensions if necessary and subject to the availability of budgeted funds, and to make any other required non-substantive changes.

PARAMEDIC PROGRAM MEDICAL CONSULTING SERVICES - FUNDS TRANSFER - SUPPLEMENTAL APPROPRIATION

WELLNESS FUND ALLOWANCE - SUPPLEMENTAL APPROPRIATION





MASTER FRINGE BENEFITS AND SALARY PLAN - RESOLUTIONS




PURCHASE - TEN (10) 16-PASSENGER PARATRANSIT VEHICLES FOR SPECIAL TRANSPORTATION DIVISION
