### **BACKGROUND**

- City Council adopted RMC 5.36 in 2022
- City currently has 24 licensed food trucks
- To date, 30 citations have been issued
- Land Use Committee met in May 2024 to receive update and discuss changes to the code based on experiences:
  - 1. Establishing "on street permitting program"
  - 2. Limiting food trucks to certain street categories
  - 3. Reporting on a speed limit study on Diana St
  - 4. Increasing number of food trucks allowable on private property

- Staff also recommends:
  - 1. Revising "Food Truck" definition to include trailers; and
  - 2. Clarifying restrictions on "metered parking" for food trucks.

### **DISCUSSION**

### Street Parking Permit Program

- City currently has Preferential Parking Zone (PPZ) program
- PPZ designed to preserve residential parking spaces
- Food Truck parking permits would require new permitting program authorized by City Council Resolution.

### **DISCUSSION**

#### <u>Limiting Food Trucks by Street Type</u>

- RMC currently restricts commercial vehicles on certain street by gross weight and axle types
- Food Trucks would be subject to those same restrictions

# **DISCUSSION**

#### <u>Speed Limit Study – Diana Street</u>

- Engineering and Traffic Study conducted in March 2024
- No issues identified
- 40 MPH speed limit is appropriate
- No additional staff recommendations for this road segment

### DISCUSSION

#### Food Trucks on Private Property

- Current code allows 2 trucks with property owner permission
- Recommendation to increase to 4 trucks under same conditions
- More than 4 could create private and public property traffic and pedestrian hazards and safety concerns
- Most Cities are silent on private property and consider this a zoning issue

#### Food Truck Definition

Staff recommends amending code to include non-motorized trailers. Currently only motorized vehicles are considered "food trucks."

### **DISCUSSION**

#### Clarification on "Metered Parking"

Staff recommends RMC 5.36.070 (E) be amended to prohibit parking in metered stalls even when the metered time period is not in effect.



This change would preserve limited downtown street parking for patrons during all hours.
