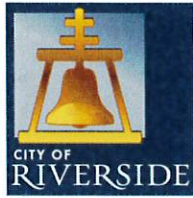
There was no one wishing to address the City Council.

Councilmember Charles Conder and former Councilmember Steven R. Adams, in their official capacity, and does 1 through 50, inclusive, Riverside Superior Court Case No. CVRI2300725; (3) §54957.6 to review the City Council's position and instruct designated representatives regarding salaries, salary schedules, or compensation paid in the form of fringe benefits of all Executive Management employees except the City Manager, City Attorney, and City Clerk, all Management and Confidential employees as defined by PERS, Fire Management Unit, Riverside City Firefighters Association, Riverside Police Officers Association (Police and Police Supervisory Units), Service Employees International Union #721, International Brotherhood of Electrical Workers #47, and Riverside Police Administrators Association; and (4) §54957 for recruitment/appointment of City Attorney by City Council.

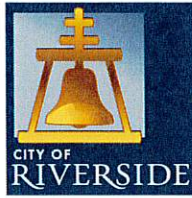
The City Council (1) approved the Memorandum of Understanding (MOU) for SEIU General Unit effective July 1, 2025, through June 30, 2028, which incorporates the negotiated revisions, and authorize the City Manager, or designee, to execute the Memorandum of Understanding on behalf of the City; (2) approved the Memorandum of Understanding (MOU) for SEIU Refuse Unit effective July 1, 2025, through June 30, 2028, which incorporates the negotiated revisions, and authorize the City Manager, or designee, to execute the Memorandum of Understanding on behalf of the City; (3) approved the changes to the compensation and benefits package for Unrepresented Employees; (4) adopted a Resolution amending the Master Fringe Benefits and Salary Plan to reflect the revised MOU provisions as outlined in Exhibit A and Exhibit B of the staff report; and (5) authorized the Chief Financial Officer, or designee, to record supplemental appropriations in the approximate amounts of \$6,970,406 in Fiscal Year 2025- 2026 in the applicable accounts. No one spoke on the matter.

Whereupon, the title having been read and further reading waived, Resolution No. 24304 of the City Council of the City of Riverside, California, Amending Resolution No. 21052 to Amend Parts I and II of the Fringe Benefits and Salary Plan, to Reflect Various Updates and Changes in Connection with the Memorandum of Understanding with the Service Employees' International Union (SEIU) Local 721 General Unit, the Memorandum of Understanding with the Service Employees' International Union (SEIU) Local 721 Refuse Unit, and the Unrepresented Employees, was presented and adopted.

Councilmember Conder arrived during Closed Session.
