### ELECTION OF CHAIR AND VICE CHAIR OFFICERS

Following discussion, it was moved by Commissioner Hirales and seconded by Commissioner Gutierrez to nominate Commissioner Norma Berrellez to continue as Chair of the Community Police Review Commission (CPRC) and she accepted the nomination. The motion carried unanimously.

Following further discussion, it was moved by Commissioner Hirales and seconded by Commissioner Gutierrez to nominate Commissioner Eileen Teichert to continue as Vice Chair of the CPRC and she accepted the nomination. It was noted that during the CPRC meeting of February 28, 2024, Commissioner Phil DeBrier was nominated as Vice Chair of the CPRC and he accepted. Following a roll call vote, Commissioners Berrellez, Teichert, Gutierrez, and Hirales voted for Commissioner Teichert, Commissioner DeBrier voted for himself, and Commissioner Prince abstained. Following a majority vote, Commissioner Eileen Teichert accepted to continue as Vice Chair of the Community Police Review Commission.
