

**FIRST AMENDMENT  
TO AGREEMENT FOR MUNICIPAL TREE MAINTENANCE SERVICES FOR CITY

This FIRST AMENDMENT TO AGREEMENT FOR MUNICIPAL TREE MAINTENANCE SERVICES FOR CITY OF RIVERSIDE ("First Amendment") is made and entered into this 6th day of July, 2021, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and WEST COAST ARBORISTS, INC., a California corporation located at 2200 East Via Burton Street, Anaheim, CA 92806, State Contractor's License No. 366764 ("Contractor"), as follows:

**RECITALS**

WHEREAS, on June 20, 2018, City and Contractor entered into that certain Agreement for Municipal Tree Maintenance Services for City of Riverside ("Agreement"); and

WHEREAS, the Agreement term was from June 20, 2018, through June 30, 2021, and the Agreement gave the City options to extend the Agreement term for three (3) additional one (1) year terms or one (1) additional three (3) year term based upon acceptable performance by the Contractor, acceptable fees and subject to the same terms and conditions of the Agreement; and

WHEREAS, City and Contractor desire by this First Amendment to exercise the option to extend the Agreement term for one (1) additional one (1) year term, beginning July 1, 2021, and ending June 30, 2022 ("Extended Term"); and

WHEREAS, City and Contractor desire by this First Amendment to establish the compensation to be paid by City to Contractor during the Extended Term to be in an amount not to exceed One Million Nine Hundred Ninety-Five Thousand Seven-Hundred Forty-Eight Dollars (\$1,995,748) during the Extended Term.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

1. Pursuant to Section 2, Term, of the Agreement, City hereby exercises its option, and Contractor agrees, to extend the Agreement term for one (1) additional one (1) year term, to begin July 1, 2021, and end June 30, 2022.

2. Section 3 of the Agreement, Compensation, is amended to add One Million Nine Hundred Ninety-Five Thousand Seven-Hundred Forty-Eight Dollars (\$1,995,748) for a contract total not to exceed Eight Million Six Hundred Seventy-Five Thousand Two Hundred Eighty Four Dollars (\$8,675,284).


3. All terms and conditions of the original Agreement not inconsistent with this First Amendment shall remain in full force and effect and are incorporated herein by this reference as though set forth in full.


