# THIRD AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT

## ALL-CITY MANAGEMENT SERVICES, INC.

Crossing Guard Program Management Services

THIS THIRD AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Third Amendment") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2024, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and ALL-CITY MANAGEMENT SERVICES, INC., a California corporation ("Consultant"), with respect to the following:

### **RECITALS**

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated July 29, 2019 ("Agreement"); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement, dated September 26, 2019 ("First Amendment") to extend the term of the Agreement until June 30, 2024, with the option to extend for one two-year term; and

WHEREAS, the City and Consultant entered into that Second Amendment to Professional Consultant Services Agreement, dated March 08, 2024 ("Second Amendment") to amend the Scope of Work to accommodate twelve (12) additional crossing guard locations at schools in the Alvord Unified School District (AUSD) and one (1) additional crossing guard location at the Riverside Unified School District (RUSD) for a total of thirteen (13) additional crossing guard locations, and to increase compensation, in the amount not to exceed One Hundred Sixty Thousand Dollars (\$160,000.00).

WHEREAS, the City and Consultant desire to exercise the Optional one two-year term to extend the term of the Agreement until June 30, 2026, and amend the Scope of Work to accommodate additional crossing guard locations at schools in the Alvord Unified School District and Riverside Unified School District, and to increase compensation, in the amount not to exceed One Million Seven Hundred Seventy-Six Thousand Seven Hundred Sixty-Eight Dollars (\$1,776,768.00) for FY2024/25, and in the amount not to exceed One Million Eight Hundred Fifty-Three Thousand Three Hundred Seventy-Six Dollars (\$1,853,376.00) for FY2025/26.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Section 1, "Scope of Services," is hereby amended by adding the additional services identified in Exhibit "A-3," attached hereto and incorporated herein by this reference.
- 2. Section 2, "Compensation," is hereby amended to increase the compensation in an amount not to exceed One Million Seven Hundred Seventy-Six Thousand Seven Hundred Sixty-Eight Dollars (\$1,776,768.00) for FY2024/25, and in an amount not to exceed One Million Eight Hundred Fifty-Three Thousand Three Hundred Seventy-Six Dollars (\$1,853,376.00) for FY2025/26, payable in accordance with the terms set forth in Exhibit "B-3."
- 3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
