A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
CALIFORNIA, APPROVING THE DESIGNATION OF THE CITY  
MANAGER OR APPOINTED DESIGNEE, TO EXECUTE DOCUMENTS  
FOR THE CALIFORNIA OFFICE OF EMERGENCY SERVICES (“CAL  
OES”) SPECIAL TRANSPORTATION CAPITAL PROGRAM

WHEREAS, the Legislature and Governor of the State of California have provided funds for the program shown above; and

WHEREAS, after City Council approval on August 22, 2017, the Parks, Recreation and Community Services Department shall submit a Grant Application to the California Office of Emergency Services (“Cal OES”) in the amount of Thirty Eight Thousand Seven Hundred Eighty-Nine Dollars (\$38,789) to install a card reader entry/exit system in the Special Transportation Administration building, and to purchase emergency response and security equipment; and

WHEREAS, procedures established by Cal OES requires a resolution appointing an authorized agent to execute any actions necessary for the Grant Application; and

WHEREAS, the City of Riverside desires to complete the necessary documents for award of the Grant.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: Appoints the City Manager, or his appointed designee, as agent to execute for and on behalf of the City of Riverside, a public entity, established under the laws of the State of California, any actions necessary for the purpose of obtaining financial assistance provided by Cal OES.
