- 4 PLANNING CASE PR-2023-001528 (CUP, DR): Proposal by Andrew Davies of N Consulting Engineers to consider entitlements to allow a fitness center (Planet Fitness) in a vacant 20,004 square-foot tenant space within an existing multi-tenant commercial shopping center including (1) Design Review of project plans; and (2) Conditional Use Permit to permit a fitness center.
