Additionally, significant changes to a project made subsequent to posting of the agenda and not addressed in the Cultural Heritage Board staff report will result in continuance of that item in order to allow for adequate review by the Commission.

It is recommended that the Cultural Heritage determine proposal is categorically exempt from Board the California Environmental Quality Act (CEQA) review pursuant to Section 15331, because the project is consistent with the Secretary of the Interior's Standards for the Treatment of Historic Properties.
