When discussion is completed, the Administrative Assistant will call for the vote for Chair and Vice-Chair. Nominees receiving the majority affirmative vote will be elected.

It is legally irrelevant whether or not a collective concurrence is reached outside of a properly noticed meeting. The mere act of e-mailing a quorum in an attempt to influence is a violation of the law.
