Upon request, this agenda will be made available in appropriate alternative formats to persons with disabilities, as required by 42 U.S.C. §12132 of the Americans with Disabilities Act of 1990. TTY users call 7-1-1 for telecommunications relay services (TRS). Listening devices are available for the hearing impaired upon request.
