

FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT WITH HDR, INC.

BACKGROUND

- 1. On November 9, 2020, the Board approved a Professional Services Agreement with HDR, Inc. in an amount not to exceed \$234,600 for the Long-Term Approach for Perfluorinated Compounds (PFAS) Treatment in response to Request for Proposal No. 2029.
- 2. The terms of the agreement are effective until November 30, 2021.
- 3. Subsequently, on January 11, 2021, the Board also approved a Granulated Activated Carbon (GAC) testing project.
- 4. This testing project would allow RPU water staff to better understand how effective the different types of media are in treating PFAS compounds.

DISCUSSION

- 1. The consultant is in the final phases of completing the final report, and one of the key content within the final report is to include a recommendations for long-term cost-effective alternatives for contaminants removal by selecting a suitable treatment technology
- 2. This report will be partially contingent on RPU's GAC testing project results to see which one is/are best suitable
- 3. The pilot study is still ongoing and will be completed by early 2022
- 4. The results of the GAC testing project are needed to have a better report with more reliable information and thus could provide a cost-saving to the City in the long run operation and maintenance
