2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, APPROVING THE ACCEPTANCE OF
4 GENERAL GRANT FUNDS FOR THE HARADA HOUSE
REHABILITATION PROJECT

5 WHEREAS, the Legislature and Governor of the State of California have approved a grant
6 for the project shown above; and

7 WHEREAS, the California Natural Resources Agency has been delegated the responsibility
8 for the administration of the grant project, setting up necessary procedures; and

9 WHEREAS, said procedures established by the California Natural Resources Agency require
10 the Grantee to certify by resolution the approval of the Project Information Package before
11 submission of said package to the State; and

12 WHEREAS, the Grantee will enter into an agreement with the State of California for subject
13 project(s):

14 NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Riverside:

- 15 1. Approves the acceptance of general fund allocation for local assistance for the above
16 project(s); and
- 17 2. Certifies that said agency understands the assurances and certification in the Project
18 Information Form; and
- 19 3. Certifies that said agency will have sufficient funds to develop, operate and maintain the
20 project(s) consistent with the land tenure requirements, or will secure the resources to do so;
21 and
- 22 4. Certifies that said agency will comply with the provisions of Section 1771.5 of the California
23 Labor Code.
- 24 5. If applicable, certifies that the project will comply with any laws and regulation including,
25 but not limited to, the California Environmental Quality Act (CEQA), legal requirements for
26 building codes, health and safety codes, disabled access laws, environmental laws and, that

1 prior to commencement of construction, all applicable licenses and permits will have been
2 obtained.

3 6. Certifies that said agency has reviewed and understands the General Provisions contained in
4 the Project Agreement shown in the Procedural Guide; and

6 7. Appoints the City Manager or his designee or the Museum Director as agent to conduct all
7 negotiations, execute and submit all documents including, but not limited to Project
8 Information Form, agreements, payment requests and so on, which may be necessary for the
9 completion of the aforementioned project(s).
