**Project Description:**

The City of Riverside would utilize the Beverage Container Recycling Grant program funds to provide beverage container recycling opportunities at local schools located in the City, which would include all K-12 schools within the Riverside Unified School District.

The grant funding would go to procurement of beverage container recycling receptacles, program promotion, and the implementation/tracking and monitoring of those materials collected.

Grant funds would go to purchasing beverage container bins for placement and installation around the campuses, co-located with existing trash receptacles, and for collection barrels to empty the beverage containers and transport for recycling. Funding would also provide signage, labeling, and administrative costs for program management.

The City of Riverside purchases recycling automated carts for new homes and replaces damaged, lost or stolen carts for customers in City serviced areas as well those in areas serviced by the franchised hauler, Burrtec Waste Industries, Inc.

Currently, there are approximately 68,000 households in the City of Riverside. The City purchases and/or replaces approximately 7,632 Blue recycling bins for fiscal year 19/20 (July 1 to June 30) which totals \$340,000. City has already exhausted 90% of the fiscal year 20/21 grant of \$80,515 just from purchasing of automated recycling carts from Toter Inc, and 10% of the grant is used for education and outreach program for recycling. City is requesting if the committee would reconsider increasing the award for fiscal year 21/22.

Due to COVID-19, all outdoor events have been put on hold, so the City was not able to organize outreach booths and promotional events which were supposed to be held and staffed during the program kick-off, back to school, America Recycles Day and Earth Day. The booths coordinated by City staff, staffed by interns/students to educate the student population on the program and how to effectively recycle on campus. Staff will also purchase advertising and promotional/print ads and billboards to encourage beverage container recycling awareness.

The City of Riverside would also utilize funds for Beverage Container Recycling Education in schools, primary, for general workshops, develop recycling guides and for assemblies and shows for beverage container recycling awareness through live streaming and online education. The City will partner with EcoHero to conduct livestream presentations to the Riverside Unified S
