# SUBJECT: DEACCESSION OF PORTRAIT OF JESUS CARLOS

### ISSUE:

Recommend that the City Council approve the deaccession of the portrait of Jesus Carlos from the Riverside Public Library.

### **RECOMMENDATION:**

That the Board of Library Trustees recommend that the City Council approve the deaccession of the portrait of Jesus Carlos from the Riverside Public Library.

### BACKGROUND:

On May 3, 1980, the Friends of Jess Carlos committee donated a photo portrait of Jesus "Jess" Carlos to the Riverside Public Library. This portrait hung at the Main Library located at 3581 Mission Inn Avenue, Riverside CA., 92501, until the library was relocated in 2021.

### **DISCUSSION:**

Jesus "Jess" Carlos was a long time Riverside civic leader and resident. He was active with the Riverside Park and Recreation Commission, the Community Settlement Association, the board of directors of the Opportunities Industrialization Center, American GI Forum, University Area Kiwanis Club and Knights of Columbus. He was the operator of Carlos Market located at 14<sup>th</sup> and Howard streets and was an unofficial spokesman in the Eastside area.

As the portrait no longer hangs in the Main Library, staff have worked with the Sanchez family, specifically Mr. Carlos' granddaughter Elizabeth Sanchez-Monville, to return the portrait to the family.

### **STRATEGIC PLAN ALIGNMENT:**
