A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 21052 AND THE MASTER FRINGE BENEFITS AND SALARY PLAN TO APPROVE THE ADJUSTMENTS TO THE SALARY RANGES **FOR** THE DEPUTY DIRECTOR, UTILITIES DISPATCH SUPERINTENDENT. UTILITIES ELECTRIC OPERATIONS MANAGER AND THE UTILITIES ELECTRIC FIELD MANAGER; AND APPROVE THE MODIFICATION OF THE FRINGE BENEFITS **PART** SALARY II. 5, PLAN, SECTION **INCLUDE** TO **SAFETY** DIFFERENTIALS THE ASSIGNMENT.

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the adjustment to the salary ranges for the Deputy General Services Director, Utilities Dispatch Superintendent, Utilities Electric Operations Manager and the Utilities Electric Field Manager; and

WHEREAS, the FBSP, Part II, Section 5, Salary Differentials, needs to be modified to include the Safety Lead Assignment.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are hereby amended to 1) approve the adjustments to the salary ranges for the Deputy General Services Director, Utilities Dispatch Superintendent, Utilities Electric Operations Manager and the Utilities Electric Field Manager classifications as set forth in Exhibit "A" attached hereto and incorporated herein by reference; and 2) approve the modification to Part II, Section 5, Salary Differentials, to include the Safety Lead Assignment.

1	Section 2: Authorize the City Manager, or designee, to make minor, non-substantive
2	changes to the Master Fringe Benefits and Salary Plan and any related policies, procedures or
3	documents necessary to implement these provisions.
