### **BACKGROUND**

#### What is a smoke-free multi-unit housing policy?

1. Local laws that regulate smoking in residential units with shared walls

#### Who adopted a smoke-free multi-unit housing code?

- 1. According to Riverside University Health System, more than 100 cities in California.
- 2. Local cities include, Jurupa Valley, Loma Linda, Temecula, Irvine, Dana Point, Culver City, Laguna Beach, Pasadena, etc.

### Why adopt a smoke-free multi-housing policy?

- 1. Secondhand smoke is toxic and travels between residential units
- 2. Chemicals found in smoke are present in air, carpet, drapes, toys, and furniture for months.
- 3. RUHS reports 93% of multi-unit housing residents are non-smokers.
- 4. 84% of residents prefer a smoke free complex.

# **BACKGROUND**

### What does Riverside currently do about smoking?

1. RMC 6.23 prohibits smoking in public places and states:

"It is unlawful for any person to smoke or to dispose of any lighted match or cigarette, cigar ashes or any flaming or glowing substance in any public place including any place within the city, public or private, that is open to the general public regardless of any fee or age requirement, including for example, city buildings, facilities, parks and community centers, bars, restaurants, stores, stadiums, service areas such as gas stations or ATM lines, playgrounds, taxi, bus or public transit stops."



2. Riverside does not currently regulate smoking in multi-unit housing.

### DISCUSSION

### Safety, Wellness, and Youth Committee Meetings and Outcomes

- 1. May 19, 2021 Committee unanimously supported concept of a Smoke-free Multi-unit Housing Ordinance and directed staff to bring back a draft ordinance.
- 2. Oct 20, 2021 Committee directed staff to address additional questions and return to Committee
- 3. Feb 16, 2022 Committee unanimously supported proposed ordinance and directed staff to bring ordinance to City Council for consideration.

# **DISCUSSION**

#### Proposed ordinance would:

- 1) Apply to all tobacco products, e-cigs and marijuana
- 2) Apply to non-owner-occupied multi-family housing except condos/townhomes/homes in single family zoned areas/hotels/motels
- 3) Require "No Smoking" signs be posted throughout property
- 4) Require new and renegotiated leases to include no smoking requirements
- 5) Allow for creation of designated smoking areas 25' from play areas
- 6) Create framework for landlords to enforce through private civil action

### DISCUSSION

#### Authority to pass such laws

- 1) Police powers granted by Article XI, section 7 of the California Constitution
- 2) Based on public health, safety, morals or general welfare
- 3) Ca Health and Safety Code 11362.3 (a)(2) prohibits smoking MJ wherever regular tobacco is prohibited

# DISCUSSION

#### **Enforcement**

RMC 1,17 authorizes the City to utilize administrative code enforcement remedies for all violations of the municipal code

- 1) Notices of Violations (warnings)
- 2) Administrative Citations (\$100/\$200/\$500)
- 3) Administrative Civil Penalties (up to \$1000/day)

The proposed chapter further expands enforcement authority by empowering private landlords and owners to bring a civil action against any person violating the provisions of this Chapter.
