## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AUTHORIZING THE SUBMISSION OF APPLICATION AND ACCEPTANCE OF GRANT AWARD FROM THE U.S. DEPARTMENT OF HOMELAND SECURITY THROUGH THE CALIFORNIA OFFICE OF EMERGENCY SERVICES FOR THE FISCAL YEAR 2021 STATE HOMELAND SECURITY PROGRAM GRANT (SHSP), WHICH INCLUDES THE COUNTYWIDE HAZMAT OPERATION GROUP (CHOG) PROGRAM, AND AUTHORIZING THE EXECUTION OF ALL REQUIRED DOCUMENTS BY THE CITY MANAGER OR HIS DESIGNEE; AND AMENDING THE BUDGET FOR FISCAL YEAR 2021-2022 ACCORDINGLY.

WHEREAS, the U.S. Department of Homeland Security (the "Grantor") has been delegated authority to award federal financial assistance for the Fiscal Year 2021 State Homeland Security Program Grant (SHSP); and

WHEREAS, the federal funds have been sub-granted to the California Office of Emergency Services; and

WHEREAS, the County of Riverside is the designated Operational Area to which California Office of Emergency Services grant funds are awarded and distributed; and

WHEREAS, the City desires to apply for and upon grant award, accept the grant award from the Department of Homeland Security in the amount of \$67,000; and

WHEREAS, the City Council desires to amend the annual budget of the City to reflect and incorporate the Grant so awarded to the City, and to increase the annual appropriations and expenditures in the appropriate City program to reflect such award.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: The City Manager, or his designee, are hereby authorized to submit a grant application for and on behalf of the City of Riverside, through the County of Riverside, and are hereby authorized to execute all actions necessary for the purpose of obtaining federal financial assistance provided by the United States Department of Homeland Security and sub-granted through the State of California, including any extensions and amendments thereof.

1	Section 2: The City Council of the City of Riverside hereby agrees to, and by this Resolution			
2	does, accept the Grant funds in the amount of \$67,000 awarded to the City of Riverside.			
3	Section 3: The City of Riverside hereby agrees to comply with each and all of the terms,			
4	conditions, and limitations, imposed by the Grantor upon said Grant, and the City of Riverside City			
5	Manager, or his or her designee are hereby authorized and directed to execute the Signature			
6	Authority document as well as any agreements, assurance, or other documents as may be necessary			
7	in connection with acceptance and implementation of said Grant as may be required by the Grantor.			
8	Section 4: The annual budget of the City of Riverside for fiscal year 2021-2022 is hereby			
9	amended by increasing the appropriations and authorized expenditures in such amount as is equal to			
10	the amount of Grant funds to be received by the City.
