PRESENTATIONS

2. Receive a presentation from SoCal Adaptive Sports regarding the creation of an inclusive society through competitive and recreational opportunities for people with disabilities.

SoCal Adaptive Sport, also known as Palms to Pines Parasports, was incorporated in May 2020 to provide adaptive sports opportunities throughout Riverside County. The vision for SoCal Adaptive Sports is "A world in which adaptive athletes have the same opportunities to lead as full a life as their

able-bodied peers." Creating adaptive sport opportunities so that every person, no matter what their ability, has an opportunity to participate. Michael Rosenkrantz explains that participating in sports is not only about the physical activity, but also about helping people become emotionally and socially fit as well. The mission for SoCal Adaptive Sports is to create a more inclusive society by providing competitive and recreational opportunities, focusing on people with physical disabilities and simultaneously working with athletes with other disabilities, while instilling a lifelong passion for wellness and helping everyone meet their full potential.

SoCal Adaptive Sports rises to the challenge of providing adaptive sports to everyone. They have key values which will allow them to be a leading adaptive sport organization. Values:

- RESILIENT They take pride in what they do, and they prepare for a future without fear, prejudice, or discrimination.
- INCLUSIVE They embrace diversity by being open to everybody wanting to participate. They seek out other perspectives and consider the impact of our decisions on the community.
- SERVICE They have the passion for compassion, and they understand and support everyone in order to bring out the best of their abilities.
- EXCELLENCE they are honest, fair, and transparent. They proactively seek out partnerships with others to create the best possible outcomes for participants.

SoCal Adaptive Sports has many goals for the future:

- Build a sustainable adaptive sports non-profit organization.
- Create a greater awareness of the capabilities of people with disabilities through outreach and support.
- Enable people with disabilities to achieve and lead fulfilling lives and to challenge themselves by playing sports in a safe inclusive environment.
- Become the go-to organization in finding resources and information for the disabled community.
- Introduce athletes to sports and wellness while assisting them in acquiring the necessary tools to participate.

Michael Rosenkrantz shared a document that listed all the highlights from 2021.

Commissioner Krick stated that he would like to see more students with disabilities being included in school sports programs.

Commissioner Aleman asked if there are age limits. Michael Rosenkrantz stated that they offer programs and events for people of all ages.
