## **RESOLUTION NO.**

## A RESOLUTION OF THE CITY OF RIVERSIDE, CALIFORNIA, AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE REGIONAL CLIMATE COLLABORATIVES GRANT PROGRAM ADMINISTERED THROUGH THE CALIFORNIA STRATEGIC GROWTH COUNCIL AND AUTHORIZING THE EXECUTION OF ALL REQUIRED DOCUMENTS BY THE CITY MANAGER OR HIS DESIGNEE.

WHEREAS, the State of California Department of Conservation (the "Grantor"), through the Strategic Growth Council, has heretofore invited public agencies, including the City of Riverside ("City"), to submit applications to the Grantor for the Fiscal Year 2021/22 Regional Climate Collaboratives Grant Program (the "Grant"); and

WHEREAS, in response to a Grant Notice of Funding Availability, the City of Riverside, a public entity, wishes to apply to the Grantor for, and receive an allocation of, Grant funds; and

WHEREAS, the City has determined that it is in its best interests to submit an application for Grant Funds for clean energy, smart growth, and affordable housing projects in-and-around the City's La Sierra Neighborhood; and

WHEREAS, the City shall submit an application to the Grantor to participate in the Grant program and for an allocation of funds of up to One Million Dollars (\$1,000,000) for clean energy, smart growth, transportation, and affordable housing projects in and around the City's La Sierra Neighborhood; and

WHEREAS, the City is familiar with the terms, conditions and limitations of any such Grant; and

WHEREAS, the City is willing and able to conform to each of the terms, conditions, and limitations imposed upon any such Grant to the City; and

WHEREAS, the Grantor must approve said application and will require the City to execute Grant funding agreement and other necessary documents upon approval.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

<u>Section 1:</u> That the City Manager or his designee are hereby authorized to execute an application for Grant funds and any and all other necessary documents for the purpose of obtaining

3	Section 2: The City of Riverside hereby agrees to comply with each and all of the terms,

6	directed to execute any applications, Grant funding and other agreements, assurances, or other					
7	documents as may be necessary in connection with acceptance and implementation of said Grant as					
8	may be required by the Grantor.
