Important: To receive these funds we need your jurisdiction to complete the budget form (<https://www.library.ca.gov/wp-content/uploads/2022/03/LATL-Budget-Insert-Jurisdiction-Name.xlsx>). To submit [the Excel form](#), log back in at the [Wizehive Web portal](#) using the same credentials used for the application. You will now see the option to upload your budget (in an Excel format) and complete the brief form on your budget fields. Remember, the total amount you submit (on the form and on the Excel file you upload) must match your funding amount (\$8,000).

Please submit the budget information via the Wizehive Web portal (<https://webportalapp.com/sp/login/lunch2022>) as soon as possible but **no later than April 4 at 4:00 PM**.

While signed into the Web portal, please also update your application to reflect any changes since you submitted your application. These changes do not affect funding amounts but it is beneficial for you to let us know. Modifications include changing tentative & speculative pop-ups/Library-based meal sites to confirmed or switching a Library-based meal site to a pop-up site.
