Chair Eric Haley convened the Charter Review Committee meeting at 3:20 p.m.
The Pledge of Allegiance was given to the Flag.
ORAL COMMUNICATIONS FROM THE AUDIENCE
One citizen spoke regarding the schedule of Charter Review Committee meetings. Jim Anderson spoke regarding the Committee members names and background information being available on the City's website.

MINUTES - CONTINUED TO LATER IN THE DAY
Due to lack of a quorum the approval of the Minutes for November 13, 2003, was continued to later in the day (see page CRC-23).

## HUMAN RESOURCES BOARD

Chair Haley reviewed the memo submitted by Human Resources Director Art Alcaraz recommending there be no changes to Charter Section 807 relating to the Human Resources Board.

## BOARD OF LIBRARY TRUSTEES

Library Director Judith Auth recommended there be no changes to Charter Section 808 relating to the Board of Library Trustees.

Member Higgins arrived during the following discussion providing a quorum for the Charter Review Committee.

## PARK AND RECREATION COMMISSION

there be no changes to Charter Section 809 relating to the Park and Recreation Commission.

Discussion was held regarding ward representation and the role of alternates on the boards and commissions. Committee members indicated their desire that all boards and commissions have alternates and that the roster include the alternates ward numbers. Assistant City Clerk Kelly Palmer reviewed the interview and selection process for the boards and commissions.

Discussion was held regarding the street tree policy including tree trimming which gives the City authority for trees in medians and on public property only with contracts for street tree maintenance (five-year trimming cycle). Planning Director Ken Gutierrez stated there are no laws or ordinances protecting trees on private property with the exception of a new tree protection policy for Victoria Avenue.

## MINUTES

Following discussion, motion was made by Member Teer and seconded by Member Castillo approving the minutes of November 13, 2003, as presented. Motion carried unanimously.

## PLANNING COMMISSION

Planning Director Ken Gutierrez recommended no changes to Charter Section 806 relating to the Planning Commission. Following discussion, the Committee recommended the City Council explore a broader role for the Planning Commission including more authority over land use matters with diversity and representation from each ward.

Committee Member Rusty Bailey entered the meeting during the following discussion.

## BOARD OF PUBLIC UTILITIES

Public Utilities Director Tom Evans summarized the Board of Public Utilities recommended changes to Article XII of the Charter as follows: (1) preference should be given to Riversidebased companies for construction contracts; (2) add to Section 1202 to allow the Board of Public Utilities to award contracts over $\$ 50,000$ within the approved City budget, without further City Council approvals; (3) amend Section 1202(b) so that in addition to exceptions for "urgent necessity to preserve life, health, and property" that customer-requested work provided under the rules adopted by the Board of Public Utilities and City Council also be exempt from City Council approval requirements (subject to ratification by the Board after the fact); and (4) add to Section 1202 delegation to the Public Utilities Director, without further City Council authorization or approval, the power and authority to enter into long-term contracts to provide water and power in accordance with approved tariffs based on current cost of service studies up to seven years in length.

Public Utilities Director Evans indicated staff does not support the first recommendation regarding local preference because bids should be awarded to the low bidders thereby encouraging competition. He also indicated there are added benefits to the City by awarding contracts to outside contractors including money spent on supplies, lodging, and meals within the City during the term of the contract.

Following discussion, the Committee requested staff to (a) acquire local preference policies from the League of California Cities of municipalities over 200,000 in population (including

Ontario, San Bernardino, Moreno Valley, and Corona) for continued discussion at a future Committee meeting, (b) investigate video conferencing as a tool to increase the pool of applicants, and (c) research Charter Section 805 relative to the Mayor appointing members to boards or commissions if there is a vacancy over 60 days.

The Committee adjourned at 5 p.m.

## SUBJECT: CITY CHARTER RECOMMENDATIONS BY THE PUBLIC UTILITIES BOARD

## BACKGROUND:

The Department of Public Utilities (PU) is uniquely described in Article XII of the City Charter. The PU Department provides electric service to approximately 100,000 customers and water service to approximately 60,000 customers. The total department budget for $\mathrm{FY} 2003 / 04$ is over 312 million ( 55.2 percent of the total City of Riverside's (City) budget).

The PU Department is comprised of approximately 410 employees who are divided into four major divisions:

- Energy Delivery
- Water
- Marketing and Customer Service
- Financial Resources.

The Public Utilities Director reports to the City Manager and the Board of Public Utilities fulfills the functions, specifically outlined in the City Charter, as well as helping set goals for the utilities.

The Public Utilities Board and senior department management developed the following strategic goals:
Attract, develop and retain quality employees
> Promote the efficient use of water and electricity
> Improve and protect the current excellent financial health of Riverside Public Utilities
$>$ Build and maintain a safe and reliable infrastructure
$>$ Expand the customer base through economic development

- Enhance community relations and customer satisfaction

These goals were a refinement of the goals established for 2001-2004. The strategic goals have been beneficial in focusing the PU Department's efforts for the benefit of all Riverside customers. Each Public Utilities Board member invests approximately 250 hours a year fulfilling board responsibilities, including the following:
> Two board meetings a month
> One committee meeting each month
$>$ Two goal setting meetings a year
> Various ad hoc meetings representing the City with elected officials in Sacramento and Washington, D.C.
> Represents Public Utilities at various community events

The utility enterprise is fiscally sound and has reserves as prescribed by bond convenants as well as reserves based on best management practices. The reserves are:

## ELECTRIC

Riverside Public Utilities provides electric service to nearly 100,000 customers, with a service area population of approximately 266,000, encompassing over 85 square miles. Riverside Public Utilities owns, maintains, and operates 85.3 circult miles of transmission lines, 1,126 circuit miles of distribution lines, 50 miles of fiber optic, 14 substations, and 4-10 MW generators.

The Electric Utility contributes 9 percent of operating revenue dollars to the City's General Fund. For FY 2002/03, this is estimated to be over $\$ 16.0$ million. This money is essential for providing needed public services, such as library books, street repair, park maintenance, and public safety.

The Electric Utility acts competitively, with a sharp focus on customers, while maintaining a financially sound utility. Compared to other local utilities, Riverside's rates are lower, reliability is higher and more funds are returned to the local community in the way of low-income assistance, rebates and community support. The Electric division is targeting efforts to increase conservation and energy efficiency, and is developing strategies to increase the amount of renewable energy in its portfolio.

## WATER

The Water Utility services over 60,000 customers, with a service area population of approximately $\mathbf{2 4 5 , 0 0 0}$, encompassing over 80 square miles. The Water Utility maintains its own distribution system, which contains 938 miles of pipeline ranging from 1 -inch to 72 -inch in diameter, 47 domestic wells, 16 active reservoirs (with a capacity over 100 million gallons), 12 miles of canals, and seven treatment plants.

The Water Utility is responsible for providing adequate water supplies to its customers. Compared to other utilities, Riverside's water rates are significantly lower. This includes assuring continued access to water resources while maintaining a high quality water supply and reliable water distribution system. The Water Utility has made significant strides in water treatment, with seven new treatment plants placed in service over the last several years. In addition, several significant water line replacements have been completed, ensuring improved reliability.

The Water Utility contributes 11.5 percent of operating revenues to the City's General Fund, which will amount to nearly $\$ 3.1$ million for FY 2002/03.

The Board of Public Utilities has reviewed the City Charter and at its November 21, 2003 board meeting adopted the following recommended changes, which will benefit Riverside customers:

- Preference should be given to Riverside-based companies for construction contracts.
- Add to Section 1202 to allow the Board of Public Utilities to award contracts over $\$ 50,000$ within the approved City budget, without further approvals.
- Amend Section 1202(b) so that in addition to exceptions for "urgent necessity to preserve life, health, and property" that customer-requested work provided under the rules adopted by the Board of Public Utillties and City Council also be exempt from approval requirements (subject to ratification by the Board after the fact)

- Add to Section 1202 delegation to the Public Utilities Director, without further authorization or approval, the power and authority to enter into long-term contracts to provide water and power in accordance with approved tariffs based on current cost of service studies up to seven years in length.

c. The Personnel Board shall have seven members.
d. The Park and Recreation Comaission shall have nine members.
e. The planning Commission shall have nine members.

Section 2: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with section 414 of the Charter of the City of Riverside. This oxdinance shall become effective on the 30 th day after the date of its adoption.
