### ORAL COMMUNICATIONS FROM THE AUDIENCE

James Anderson asked if the Committee accepted comments from the public and was advised it would be appropriate to submit his comments at this time.

### **MINUTES**

Following discussion, motion was made by Member Leach and seconded by Member Haley, approving the minutes of January 8, 2004, as amended clarifying Councilmember Hart's comments on the election of councilmembers and run-off elections. (See page CRC-25). Motion carried unanimously.

Chair Haley announced he will be meeting with Vice Chair Johnson to develop a matrix to compile the data to-date and opinions expressed. The City Attorney's office has drafted a form that will include issues and positions, and later recommendations will be added. Staff was requested to prepare this form in detail and include as part of each meeting's Committee packet.

### INTERVIEW WITH COUNCILMEMBER-ELECT ART GAGE

Councilmember-elect Gage presented the following issues for the Committee's consideration: (1) language in the Charter for public works contracts should be changed to provide an advantage to Riverside-based businesses; (2) the process for determining the Mayor and City Council salaries should be tied to an external factor and/or cost of living increase and the City Council should not set their own salaries nor have to vote on their own salary; (3) the Mayor's and Councilmember's Salary Commission should be eliminated; (4) whether Councilmembers are full or part-time is determined by the amount of time required to run the City; (5) the Park

### INTERVIEW WITH COUNCILMEMBER-ELECT STEVE ADAMS

Councilmember-elect Adams offered comments on the following: (1) does not favor at-large elections for Councilmembers or instant run-off and would like to see a run-off election 30 days after the general election; (2) the setting of the Mayor and Councilmember's salary should be tied to an external factor, an appointed committee, or an automatic pay raise; (3) to eliminate controversy the City Council should not vote on their own pay raise and after an acceptable system is in place the Mayor and Council Members Salary Commission should be eliminated; (4) the Mayor should not be granted the power to vote and his powers should not be increased; (5) favors the current City Manager form of government; (6) feels that each Ward should have at least one representative on each board and commission; (7) preference should be given to Riverside based businesses for public works contracts; and (8) would favor the election of the Mayor to coincide with the Presidential election.

Councilmember-elect Adams felt he did not have enough experience at this time to comment on (1) appointments to City Council standing committees; (2) full-time vs. part-time Councilmembers; and (3) whether all the Boards and Commissions should be included in the Charter.

### INTERVIEW WITH COUNCILMEMBER-ELECT BETRO

Councilmember-elect Betro thanked the Committee and offered comments on the following matters: (1) the method of setting the salaries for the Mayor and Councilmembers should be the recommendation of the Mayor and Council Members Salary Commission and considered final, not subject to vote/overrule of the Councilmembers or the salaries should be set and fixed in the Charter; the Mayor and Councilmembers should not determine their salaries; (2) feels the Mayor is a full time position with the Councilmember positions defined as part time with an expected 30 hour per week commitment and scheduling flexibility; (3) increase the roles and duties of the Boards and Commissions giving more decision-making responsibility to staff and Board or Commission as long as there is a process for appeal to the City Council; (4) favors run-off election with the ballots due six weeks after Election Day (before the holidays begin) with the term of office beginning on January 1st; (5) the election of the Mayor should be tied to the presidential election year to insure the greatest possible turn out of voters; (6) Councilmembers should be elected by Ward; (7) the Mayor should not be granted a vote but feels the Mayor should be responsible for conducting the evaluations of the City Manager, City Attorney, and City Clerk; (8) feels the current number of Wards is sufficient; (9) feels the City Council standing committees should elect the Chair; and (10) favors local preference to bidders on public works contracts.

### **CHARTER SECTION 805 - BOARD AND COMMISSION VACANCIES**

Without formal motion, the Committee unanimously continued discussion of Charter Section 805 - Board and Commission vacancies.

The Committee adjourned at 7:10 p.m.
