THE BACKGROUND PROCESS



BACKGROUND INVESTIGATIONS

1. The case is assigned to a Background Investigator.
2. The Initial Interview is scheduled with the applicant.
3. Documents are explained and signed.
4. The Personal History Statement and Personal Information Questionnaire are reviewed.
5. A polygraph examination is scheduled
6. The neighborhood and residence check is conducted.



BACKGROUND INVESTIGATIONS

7. Contact with all employers.
8. Contact with all references.
9. Review and approval of the background investigation.
10. Command Staff Interview.
11. Medical and Psychological examinations.



BACKGROUND INVESTIGATIONS

TIMEFRAME TO COMPLETE A BACKGROUND INVESTIGATION



BACKGROUND INVESTIGATIONS

- **Police Officer (Trainee)** typically takes four to six weeks to complete.
- **Police Officer (Lateral)** typically takes a little longer due to file reviews and their current or previous law enforcement agencies.
