AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING 2 THE ZONING MAP OF THE CITY OF RIVERSIDE PURSUANT TO CHAPTER 3 19.090 OF THE RIVERSIDE MUNICIPAL CODE BY REZONING A 0.47-ACRE PORTION OF A 5.01-ACRE PARCEL LOCATED AT 18049 CLARKE COURT, 4 FROM THE R-1-1/2 - SINGLE FAMILY RESIDENTIAL ZONE TO RC -RESIDENTIAL CONSERVIATION ZONE. 5 6 The City Council of the City of Riverside, California, does ordain as follows: 7 Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of 8 the City of Riverside is amended by removing from the R-1-1/2 Single Family Residential Zone and 9 placing in the RC – Residential Conservation Zone, a 0.47-acre portion of a 5.01-acre parcel located 10 at 18049 Clarke Court, identified as Assessor Parcel No. 276-010-061, described and depicted in 11 Exhibit "A" attached hereto and incorporated herein by reference, subject to all of the conditions, 12 restrictions and covenants imposed under Planning Case Number P09-0173, which conditions, 13 restrictions and covenants are incorporated herein by reference. 14 Section 2: The City Clerk shall certify to the adoption of this Ordinance and cause 15 publication once in a newspaper of general circulation in accordance with Section 414 of the Charter 16 of the City of Riverside.
